

# Bonita Highlands Homeowners' Association Board of Director's Meeting Minutes

June 10, 2025 – In Person Meeting

#### 1. Call to Order.

The meeting was called to order by the President who welcomed everyone and highlighted the guidelines for the meeting. It was conducted by "Roberts Rules of Order," with those wishing to speak before the Board addressing the chair, recognized, identifying themselves by name and Highlands' address. The chair limited comments to a reasonable time per individual to ensure adequate time for all individuals to speak. The President stated the meeting was being recorded to assist the Recording Secretary in taking Minutes.

- **d. Next Board of Directors (BOD) Meeting**. The next regularly scheduled BOD Meeting will be at 6:00 p.m. on August 12, 2025, at Bonita Sunnyside Fire Station, 4900 Bonita Road.
- **e. BOD Meeting Minutes**. There was a review and adoption of the BOD Meeting Minutes from May13, 2025, BHHA BOD and Homeowners Meeting.

## 2. Homeowners' Appearances

- a. Homeowner Appeals to Fines. There were no homeowner appeals.
- b. Open Forum for Homeowners.
  - Homeowner on Belle Bonnie Brae expressed concern about the motorized vehicles in open space by the horse ring. The electric vehicles were described as electric motor bikes (dirt bikes/motorcycles and quads), not electric enhanced bicycles. The discussion included the following:
    - President suggested we look at signs on trails and ask San Diego County Parks and Recreation to update signs, as well as talk with the sheriff.
    - Updated Rules and Regs might include power limitations and wheel size.
    - The Treasurer suggested research be done before the decision is made.

 Open Space Committee to develop input for Rules and Regs for trail use, determine what is legal on the trails as well as what the County recommends on enforcement.

# 3. Committee and Staff Reports.

  - 1) 3624 Filly Lane. ACC-A and the President will go and look at the retaining wall and make a decision on what the owner needs to do to complete the project.

## **Key Issues and Updates:**

## Aztec Landscape:

- 1) Irrigation Inspection Given full credit for JAN 2025 water bill. OSC told Aztec they are required to notify him when they are doing any work other than bi-weekly mowing.
- Overgrown deferred trail maintenance. The last maintenance focused on most overgrown trails. OS Committee identified trail entrances to be added and numbered to trail entrance contract. New focus on all entrances with light trimming where needed.
- 3) Water Box (control) on Sprinter installed. Work completed and confirmed.

#### **City of Chula Vista**

1) Trail Maintenance between Country Trails and Corral Canyon was completed.

#### Other Issues and Updates

- 1) Fencing and trash removed from baseball diamond in Open Space off Steeplechase.
- 2) Beehive in Cox Box on Central addressed
- 3) Identified slope failure related to storm drain runoff at Blacksmith and Country Trails. (south side). Follow up needed.

4) Inputs provided to address the ATV, dirt bikes, and electric motorcycle issues.

## Requests for Board:

- Approval for maintenance of remaining trail entrances which include both horse ring entrances. See below\*
- 2) Approval of Tree Maintenance see below\*
- 3) Till horse rings and remove the mound of dirt being used as a jump for motorcycles
- 4) Start date for Open Space mowing to be last week of June.
- 5) Aztec proposal # 3464 for lacing trees no more than 20-25%, to clear all structures by 2-3 ft. and raise canopy to allow for vehicle and pedestrian clearance.
- 6) Cost \$8,160.00
