

ADJOINING PROPERTY FOR ANNEXATION

PARCEL 1:

Quarter section 6 and Quarter section 7 of and in Rancho de la Nacion, in the County of San Diego, State of California, according to map thereof No. 166, filed in the Office of County Recorder of San Diego County.

Excepting that portion of the Westerly 20 feet of said Quarter section 6, which lies Northerly of a line described as follows;

Beginning at a point on the Northerly line of said Quarter section 6, distant South 71°00' West 820 feet, from the Northeast corner thereof; thence South 19°00' East 1936.00 feet; thence South 71°00' West 1800 feet, more or less, to the Westerly line of said Quarter section 6.

Also excepting those portions of said Quarter sections 6 and 7 lying Easterly of a line described as follows;

Beginning at a point in the Northerly line of said Quarter section 6, distant thereon 1000.00 feet Westerly from the Northeasterly corner of said Quarter section; being point 1 of this description; thence Southerly parallel with the Easterly line of said Quarter section, a distance of 1200 feet to point 2 of this description; thence continuing Southerly along said parallel line a distance of 465 feet to point 3 of this description; thence continuing Southerly along said parallel line a distance of 245 feet to point 4 of this description; thence continuing Southerly along said parallel line a distance of 380 feet to point 5 of this description; thence continuing Southerly along said parallel line and parallel with the Easterly line of said Quarter section 7, a distance of 455 feet to point 6 of this description; thence continuing Southerly along said parallel line a distance of 366 feet to point 7 of this description; thence continuing Southerly along said parallel line a distance of 330 feet to point 8 of this description; thence continuing Southerly along said parallel line a distance of 370 feet to point 9 of this description; thence continuing Southerly along said parallel line 558 feet to point 10 of this description; thence continuing Southerly along said parallel line 400 feet more or less to the Southerly line of said Quarter section 7 and the true point of beginning of the herein described line; thence Northerly to a point distant 150 feet Easterly at right angles to said parallel line from said point 10;

thence Northerly to a point distant 150 feet Easterly at right angles to said parallel line from said point 9; thence Northerly to a point distant 252 feet Easterly at right angles to said parallel line from said point 8; thence Northwesterly to said point 7; thence Northerly along said parallel line to said point 6; thence Northerly to a point distant 100 feet Easterly at right angles to said parallel line from said point 5; thence Northwesterly to a point distant 140 feet Westerly at right angles to said parallel line from said point 4; thence Northerly to a point distant 170 feet Westerly at right angles to said parallel line from said point 3; thence Northerly to said point 2; thence Northerly along said parallel line to said point 1.

PARCEL 2:

All that portion of Quarter section of Rancho de la Nacion, in the County of San Diego, State of California, according to map thereof by Morrill No. 166, filed in the Office of County Recorder of San Diego County, described as follows:

Beginning at the Northwest corner of said Quarter section 6; thence North 71° East along the North line of said Quarter section; 20 feet to the Northwesterly corner of land described in deed to William A. Toms, recorded February 14, 1916, in Book 698, page 190 of deeds; thence South 19° East along the Southwesterly line of said Toms' land, being also along a line 20 feet Northeasterly of and parallel with the Southwesterly line of said Quarter section; 1936 feet to the Southwesterly corner of said Toms' land, said point being also in the Northwesterly line of land described in PARCEL 1, in deed to L.A. Thomson, et al, recorded May 24, 1948, in Book 3205, page 247 of official records; thence South 71° West along the Northwesterly line of said Thomson's land, 20 feet to the Southwesterly line of said Quarter section; thence North 19° West along the Southwesterly line of said Quarter section, 1936 feet to the Northwesterly corner thereof and the true point of beginning.

PARCEL 3:

The Northeasterly Quarter and Easterly 465 feet of the Northwesterly Quarter of Quarter section 21 of Rancho de la Nacion, in the County of San Diego, State of California, according to map thereof by Morrill No. 166, in the office of County Recorder of San Diego County.

PARCEL 4:

The South half of Quarter section 21 of Rancho de la Nacion, in the County of San Diego, State of California, according to map thereof No. 166, filed in the office of County Recorder of San Diego County by Morrill.

Excepting from all of the above described property that portion thereof lying within McMillin's Bonita Highlands Unit No. 1, according to map thereof No. 7563.
