I have heard, April showers bring May flowers. The exception may be Southern California. Our rainfall this year hasn't brought much in the way of flowers. All we can do is hope and pray for April to bring us a little more rain. Some of our native plants are blooming, but mostly weeds and non-native grasses are growing along the trails. Still, get out and take a walk.

Speaking of weeds and grasses, our landscape contractor, LandCare is working on getting the trails mowed and the trail entrances cleaned up. They have finished the horse rings and along the trail east of Corral Canyon. May is when we typically begin mowing the open space and cleaning brow ditches. Look for them to be out and about in the open space over the next couple of months. If you see them working, please don't ask them to complete any other work. The guys on the trails are not the guys who make the decisions about prioritizing work. Please contact the Association by email at *bhighlander@cox.net* with any questions you may have.

Our Bonita Highlands is a unique area. Please get out, explore, and enjoy it. We have two horse rings on the west side of Corral Canyon Road. Until I became the Open Space Chair, I had no idea where they were. They have both been mowed and are beautiful. Access the upper ring area from either Ring Road (between 3718 and 3726 Corral Canyon) by foot, bike, or horse anytime, or by the trail that runs next to the green space on Corral Canyon. The lower ring can be accessed from the Mirar Court cul-de-sac (off of Belle Bonnie Brae). Have a picnic under the beautiful trees. If there is a horse or two in the upper ring, please be respectful.
