From the Open Space Chair

BHHA and Homeowners – A Valuable Partnership

Keeping our neighborhood and open space beautiful and safe is a partnership between BHHA and the homeowners. We need your help and participation.

It was nice having our fireworks back this year. The San Diego fireworks display is now a famous destination and many of us can view them from our backyards or the open space. However, private use of fireworks in San Diego County is illegal. This includes firecrackers, bottle rockets, cherry bombs, even sparklers. Yet every year a few Bonita Highlands homeowners set off their own fireworks before, during, and after, sometimes days after, our spectacular and legal July 4 displays. Fireworks can start fires and animals can be sensitive to the noise. The anxiety caused by the "popping" noise can lead a dog to frantically try to escape. Dog owners can take measures to control this during the legal, planned firework displays, but not during random bouts of fireworks. We ask that you obey the law and refrain from any private firework use.

Recently, two off-road bikes were using the upper horse ring. It is not known if these were residents of Bonita Highlands. There are no motor vehicles allowed on our trails unless prior permission is granted by BHHA and a monetary bond is posted. E-bikes are not allowed on Bonita Highlands trails.

The mowing of the open space should be complete by the printing of this newsletter, except for the Proctor Valley trail. The trail is clear, but the weed whipping has not yet been completed. If you happen to see an area that was missed, please send an email to bhighlander@cox.net and let us know the location. Photos are helpful. Get out and enjoy the trails!

Mowing of the open space takes us into all the nooks and crannies. As such, homeowner violations of the Covenants, Conditions, and Restrictions (CC&R's) and Rules and Regulations (R&R) were noted. If you need to look at them, both documents are available on our website at https://bonitahighlands.org/. "Fix-it" letters were sent. If you received a letter and cannot make the repair within the 10 days, we ask that you contact us at the email address above and let us know. If you do not communicate with us and fail to make the repair, a fine warning letter will be sent, and the fine process will begin. The top three violations per the Rules and Regulations are:

Section 5.3.b. Shrubs, trees, and other plants growing onto the open space or into a neighboring residence from a residence lot must be cut back by the homeowner to end the encroachment.

Sections 5.4. Proper drainage of lots is usually towards the street, and landscaping shall not prevent this flow. Where a brow ditch is on a residence lot, it is the responsibility of that homeowner to maintain the ditch and keep it clear of obstructions to facilitate drainage. Failure to comply may result in liability for damages caused.

Section 9.2. Dumping of any material onto the common area is prohibited. "Material" includes, but is not limited to, trash, rubbish, garbage, tree trimmings, shrub trimmings, rocks, concrete, soil, building materials, and animal waste.

Regarding Section 5.3b., many of the plants escaping homeowner properties are invasive species. They will drop seeds or spread through the open space causing a maintenance burden for the HOA. Some plants may be blocking the trail or the trail entrance.

Please, be a good neighbor and clean up after a project. Do not leave brush or tree trimmings in the open space. This results in additional work for our contractor and additional costs to the HOA. It is much easier for you to remove the brush to your trash container than it is for the contractor to carry it through the open space to a trail entrance. If you have brush that is growing in the open space that you feel needs to be cut back, please contact us. Many homeowners desire the native brush for privacy. We do encourage our homeowners to maintain the 6 feet behind their property. If you choose to do this, please do not leave the clippings in the open space. Homeowners are responsible to make sure a contractor is not using the open space as a construction materials dump. When debris is found behind your fence, you will be contacted. Your help is appreciated in keeping our open space beautiful and safe.

A brow ditch that is blocked keeps storm water from flowing freely and causes flooding. If you need to keep an animal in, or out, there are measures you can take to keep the water flowing. Please contact us and we can give you examples of how neighbors have tackled the problem. Brow ditches are an important part of the drainage system in Bonita Highlands.

In the next few months, we will be working on the irrigation system, additional plantings in our cultivated areas, and more tree work. I will try to contact homeowners if work will be taking place near your property. An email address makes this easy. Get out and enjoy the beautiful trails in Bonita Highlands. BHHA thanks you for taking care of maintenance issues quickly.

IMPORTANT: CA LAW REQUIRES ALL HOMEOWNERS PROVIDE INFORMATION TO HOA'S

A law, effective January 1, 2017 (Civil Code, Section 4041), requires each owner of a separate interest to provide written notice regarding certain information to the Association on an annual basis. The information required by each homeowner is the following:

- 1) address or addresses to which notices from the Association are to be delivered,
- 2) alternate or secondary address to which notices from the Association are to be delivered,
- 3) name and address of Homeowners' legal representative, if any, with supporting documents, &
- 4) if the home is owner-occupied, rented, or vacant.

BHHA includes the request for this information on a form called, **Annual Notice for Request of Address, Representative and Rental Status (ANNARS)** with the Audited Financial Statements' mailing each September. <u>Only return the ANARRS if you have never submitted one **OR** if any information has changed since your last submission.</u>

If the required information is NOT provided, the property address will be deemed the address to which notices are to be delivered.


