A Note from the Board of Directors

Annual Assessment Dues

The Bonita Highlands Homeowners Association (BHHA) has been incredibly lucky over the past few years in maintaining the same rate for our homeowner Annual Assessment. However rising costs have now caught up with the Association, and this year it will be necessary to implement an approximate 18-20% increase in the Annual Assessment in order to meet our current FY24/25 budget costs/obligations. The new Annual Assessment will be \$534, which when you break it down is only \$44.50 per month; \$10.27 per week; \$1.46 per day.

The maintenance and care of our Open Space area is one of our biggest costs. We are so fortunate to have this beautiful open space that offers so many benefits to each of our homeowners. Whether we walk or hike any of the 7+ miles of trails or just enjoy the openness of our 106 acres of open space, it's really nice to have homes that are not track-stacked next to each other on all sides. We also benefit from all this open spare area in that we have a nice maintained buffer of land between properties that no one can ever build on, which ensures the open and rural feel of our community. But this area has to be maintained from a safety standpoint which includes compliance with state and county fire regulations. The BHHA is in the final stages of executing a new landscape maintenance contract, and has spent a fair amount of time over the past few months on the process with nine interested companies. At the final stage of this process, the Association had only received two bids, with the other companies bowing out for a variety of reasons. The received bids were evaluated and the BHHA negotiated with each company to ensure we had the best possible price. Plus, in the interest of keeping costs down, the BHHA even removed some of the tasks that will be taken care of by the BHHA. Nevertheless, the total cost for the maintenance contract has increased substantially and it is necessary to increase the assessment to meet these costs.

While the maintenance of the open space will be our biggest single cost increase this year, almost everything else has gone up as well over the past year or so, i.e., insurance, water, postage, printing, etc. The one thing all of us can help control is the cost of printing and mailing Association documents to ourselves. The BHHA continues to encourage homeowners to sign up for Electronic Transfer Consent (ETC) which allows the Association to send information like the required Monthly Newsletter and other various forms, documents, and information to homeowners via email, which greatly decreases the Associations costs for printing and postage for these types of items. Elder Fraud Schemes

SVCA presented a program from the FBI on Elder Fraud at their January 3rd meeting. Here are some of the Schemes:

- Romance scam: Criminals pose as interested romantic partners on social media/lonely seniors.
- Tech Support Scan: Criminals pose as tech support reps and offer to fix non-existent computer issues.
- Govt. Impersonation Scam: Criminals pose as government employees and threaten to arrest or prosecute victims unless they agree to provide funds or other payments.
- Home Repair Scam: Criminals appear in person and charge homeowners in advance for home improvements services they never provide.
- Family/caregiver scam: Relatives or acquaintances of elderly take advantage of them or otherwise get their money.

Protect Yourself:

- Resist pressure to act quickly. Scammers create a sense of urgency to produce fear. Call police if you feel you are in danger.
- Be cautious of unsolicited phone calls, mailings and door-to-door services.
- Never give or send personally identifiable information, money or valuables to unverified people
- Disconnect from internet or shut down device if you see pop up message or locked screen.
