- The water leak on Corral Canyon should be fixed and paving restored to its original condition by the County of San Diego by the time you read this. This has been a lengthy task for several reasons, but suffice it to say that the job has been completed.
- You may notice that the speed limit on Corral Canyon has been reduce to 30 mph. This should make Bonita Highlanders who live on Corral Canyon happy as some daily commuters and transient drivers seem to always go at least 5 mph faster than the posted speeds. The old limit of 35 mph often resulted in drivers going 40 mph or more. Of course, lowering the limit to 30 mph will also require CHP Officers to enforce the new, lower limit or it will be just a "paper tiger." (You older folks probably know what a paper tiger is, but younger folks should look up the term, as it is significant and often encountered in our daily lives.)

IS THAT A WITCH OR A DITCH?

April showers bring May flowers, but in San Diego, October is the best month to get our yards and the open space ready for the spring bloom. In checking the *Farmer's Almanac*, the rain forecast for Southern California is for a warm, dry winter. This means an average to below average rainfall, again. A major task for the open space crew is the brow ditch cleaning regardless of whether the forecast is for rain or not. The contractor will be out in the open space during the month of October clearing the brow ditches of leaves and debris. As October is a great month to add new plants to the landscape, we will also be doing a general maintenance of our cul-de-sacs and adding some new color.

Homeowners should consider taking this time to clear the brow ditches on their property as well. The BHHA Rules and Regulations section 5.4. state that "Proper drainage of lots is usually towards the street, and landscaping shall not prevent this flow. Where a brow ditch is on a residence lot, it is the responsibility of that homeowner to maintain the ditch and keep it clear of obstructions to facilitate drainage. Failure to comply may result in liability for damages caused."

Please check that your brow ditch is clear of debris and that it is not blocked with bricks or boards where it adjoins to the open space or your neighbor. The brow ditches in Bonita Highlands were installed by the developer and have been located to insure proper drainage of the open space and resident lots to the street. Obstructing the ditches could lead to flooding and erosion. Some residence lots may have the brow ditch on the outside of their yard fence, yet still on their property. If you received a letter last year regarding a brow ditch, then you have a brow ditch on your property and are responsible for the maintenance of it. If you feel there was an error, please contact us.

Also, notice that Section 5.4 also addresses the issue of storm water (rain) drainage from the residence lots as being "toward the street." Storm water drainage by homeowner installed pipes, channels, gutters, or other manufactured means from lots to trail entrances, onto trails, or into the open space is prohibited. The only exception to this rule is lots where the storm water is draining to a brow ditch. This does not include backwashing or the discharging of treated pool water. All treated pool water is to be discharged into the sewer. Please see the County of San Diego regulations on discharging of pool water into the storm drain (street) on their website: www.sandiego.gov/sites/default/files/pools_and_spas_final_2016.pdf

October is also a great month to check your irrigation timers to reduce watering as well as checking for leaks. With cooler weather coming and the sun heading into the Southern Hemisphere, irrigation can run for a shorter time. Fruit trees will not need to be watered as often, either. Most native or xerophytic (drought tolerant) plants will require no water until next summer, even if our winter is dryer. The Highlands will be reducing our water on the green belts (we have warm season lawns that go dormant in winter), as well as reducing our need for weekly mowing. All these measures equal savings to our homeowners.
