### Financial Information & Acceptance of ILCC Bylaws & Policies

I hereby apply for Membership in the **INDIAN LAKE COUNTRY CLUB ("ILCC")**. As a consideration for my acceptance as a Member, I agree to maintain my Membership at ILCC for a period of one year from the date this Application is submitted (the "Initial Membership Term"). As additional consideration, I further agree to pay the Monthly Dues of \$\_\_\_\_\_ for all months of the Initial Membership Term after March 31, 2019, which may be adjusted from time to time pursuant to ILCC's By-Laws, and which shall be due and owing to ILCC whether or not I withdraw or resign my Membership prior to completion of the Initial Membership Term. I further agree to pay in full all additional charges made by me or my authorized family members at ILCC including the monthly food and beverage minimums of \$\_\_\_\_\_, as may be adjusted from time to time. I understand and acknowledge that I am responsible for all other charges made by me or my authorized family members at ILCC, including the monthly food and beverage minimums, whether or not Dues are being charged. I also agree to abide by ILCC's By-Laws, Club Policies and Member's Code of Conduct, and all other rules and regulations of ILCC, including without limitation the following payment policy, with the exception of Annual Dues during my Initial Membership Term.

### Annual Dues Payable Monthly and Payment Policy.

The total Annual Dues are owed in full by March 16<sup>th</sup> of each year, but may be paid at your selection in equal monthly increments as established by ILCC's Board of Directors with payment due by the 10<sup>th</sup> of each month. Dues will not be charged annually during the Initial Membership Term, but shall be charged annually after the Initial Membership Term expires. If the monthly portion of Annual Dues (or Monthly Dues during the Initial Membership Term) and all other currently outstanding charges are not paid by the end of business on the 15<sup>th</sup> day of the same month, overdue Members will be assessed a \$25.00 late fee and on the 16<sup>th</sup> day of the same month the Member's and associated family members' privileges (golf, swim, food/beverage), as well as any other available rights or remedies, are suspended until payment is made in full. If all past due amounts are not paid by the end of the month, ILCC's Board of Directors may declare all remaining Annual Dues (or remaining Monthly Dues during the Initial Membership Term) immediately due and payable in full, in addition to any other available rights and remedies. Delinquent Members will be charged interest monthly on all past-due amounts at a rate of eight per cent (8%) per annum and will be responsible for all costs of collection for past-due amounts as more fully described in the Credit Card Authorization section of this Application.
