I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient, in consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prize money, ribbons or trophies. I (we) agree to hold the event giving club, their members, directors, governors, officers, agents superintendents or event secretary and the owner of lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any lure operator at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near an entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
