INTRODUCTIONS:

Director Peggy Weems invited attendees to introduce themselves. All participants stated their names and roles.

APPROVAL OF SEPTEMBER 22, 2025 MINUTES.

MSA/Carol Helton/Rod Powell motioned to approve the September 22, 2025 minutes, as amended with the addition, per Director Peggy Weems, that the 2025 Region 4 show had total loss of \$22,033.58 All in favor. Motion passed unanimously.

RATIFICATION OF NEW SHOW COMMISSION MEMBERS – Director Peggy Weems.

Director Peggy Weems reported that two Show Commissioners, Dawn Gossler, and Deb Witty, had resigned from their positions. Director Weems subsequently appointed Doug Stewart and Kendyl Modrich to fill the vacant seats.

MSA/Julie Hedden/Naomi Richmond made a motion to approve the appointments of Doug Stewart and Kendyl Modrich to the Show Commission. All in favor. Motion passed unanimously.

DIRECTORS REPORT – Peggy Weems.

Director Peggy Weems provided a brief Show Commission Report. She stated the Region 4 Horse Show has been moved to the Oregon Horse Center and the dates will be May 20-24, 2025. She also stated Show Manager Patty LeBon received the contract today from The Oregon Horse Center. She went on to say a Show Commission meeting is scheduled for Monday, November 24, 2025.

BUDGET – Chris Bickford.

Due to unforeseen circumstances Chris Bickford was unable to attend the meeting. Also the Show Commission did not get the Region 4 Show contract in time to create an accurate budget, so it was discussed to move the approval of the Region 4 budget to a later date.

MSA/Rod Powell/Julie Hedden motioned to have the Budget discussion and approval moved to a time and place to be determined.

All in favor. Motion carried unanimously.

OTHER BUSINESS.

Rod Powell provided an update on the Futurity for the Region 4 show. He reported that there will be no reining or cow class futurities this year, as entry data from the past ten years shows fewer than two entries in those classes. However, a Ranch Rail Derby for horses six years and older will be added. He also noted that the futurity buckles have been ordered and recommended conducting bi-weekly meetings of the Show Commission and also with the Oregon Horse Center to monitor the status of the facility and event.

NOMINATING COMMITTEE REPORT.

Director Peggy Weems stated that the Nominating Committee will present its recommendation for Board Officers at the Spring Meeting, and the election of Officers will take place at that time.

DISCUSS DATE AND TIME OF SPRING MEETING.

The Region 4 Spring meeting will be an online meeting Sunday, March 1, 2026 at 10:00 a.m.
