- USEF Membership increase from \$55 \$80
- Studies are being conducted on drugs and the affects
 - o Rule changes are expected to be forthcoming once studies are complete.
 - o They are also looking to make the rules more similar between Canada and the US.
- 50% of all Membership Chairs and Directors do not open their emails.
- New videos featuring arabians will be available soon on HorseChannel.com
- Convention planning is in the works and on track.
- Stan Morey reported there are 282 R Arabian Judges and only 104 Stewards. We are in desperate need of stewards across the country!
- The # of judges at US Nationals was discussed. 3 Judge system with a Penalty Judge.
- One Day Shows are now overseen by the Competition Advisory Committee.
 - o They want to maintain the simple, reasonable, fun and pleasant atmosphere of the shows but expand the program. Proposals are being discussed and will be forthcoming at convention.
- Sweepstakes is asking for Revisions
 - They want to attempt to balance the payout between Canadian Nationals, US Nationals & Sport Horse Nationals in the Yearling classes.
- Class Changes will be forthcoming at convention, mostly clarifying language.
- Scoring System Education Class being offered at National Convention.
 - There is a need across the nation for more scorers and they are planning on offering a class at National Convention to help.
- They are attempting to shorten the board meeting, so directors are able to meet and brain storm resolutions to issues and ideas in their individual regions.
- A vote was taken at the meeting to allow show commissioners to work on 2 National Show Commissions. This was proposed due to a medical resignation.
