## **Road District Report October 2024**

<u>Muirhead Bridge:</u> We finally have a signed agreement with Canadian National Railway for the Muirhead bridge project. We are still working on finalizing the easement process as an old easement was found, we just need to modify it to the current easement needs. The bridge is scheduled to go out to bid for construction January 2025.

Repaving: The Road District has removed and regraded the required 350 plus cubic yard area required to create the compensatory storage on the Forest Preserve property just south of Bahr Rd. This will allow for the pulverization and repaving of Bahr Rd. through the flood plain in that area. Kane County Water resources has approved the storm water permit for the project. We will remove the silt fence and the access to Bahr Rd. after completion of the seeding. Peter Baker was the low bid on the project and the pulverization will take place in early October followed by the repaving of Bahr Rd from Plank Road to the Burlington Township line. The pulverization and repaving of Bahr Rd will be paid for using Hard Road Tax funding.

The final lift of binder will be placed on Bahr Rd tomorrow and the surface will follow sometime this week. We have 250 yds of recycled cement /ca6 staged in the yard so we can restore the shoulders to the road once the paving is complete.

**Road Salt for 24/25 winter:** The salt bid came in a t \$76.00 per ton for dry white road salt, that is about ten dollars per ton cheaper than last year. Our bid is through the county this year. The new vendor is Skyline Salt Co. and our account and delivery information has been set up. We are ready to receive salt.

Our chemical treatment price came in at \$1.14 per gallon, it stayed within 5 cents of last year's prices.

**Mowing:** We are mowing fenced lines as the fields are being harvested.

**Mosquito Abatement:** We have applied the last larvicide treatment to the roadsides and park the end of September. We applied larvicide seven times this year.
