Road District Report March 2024

We are trying to reach a June letting for the Muirhead bridge replacement.

HLF engineering has had quite a time trying to receive a response from Canadian National Railroad as to easement requests. I finally got a response from the Railroad after numerous phone calls per day over a week and half period of time. We still need to purchase or verify existing easements. This process for the obtaining the easements will be the last hurdle to clear before the June letting.

Chippewa Pass and Lori Lane 2024 resurfacing has been put out to bid through the county with the intention of using Rebuild America and MFT funds.

The bids will take about three weeks to receive the bids and finalize the resurfacing.

We have removed multiple beaver dams from the pond system and the drainage is functioning as it should but the beavers are a constant issue that keeps the drainage questionable from week to week.

The Road District will be meeting with the Forest Preserve in April to try and reach an agreement on the construction of some 150+ sq yds of compensatory storage needed to offset the elevation the surface of Bahr Rd. in a section of wetlands near Forest Preserve property.

We will be submitting a bid for road salt for 2024/25 this month using either the County or State bid process.
