Seconded by Linda. All in favor.

<u>Election Advertising Guidance</u> – The Board reviewed the document prepared by Mike and gave it to Craig for his use in the upcoming election season.

<u>Architectural Guidelines Review Process</u> – The Board reviewed and agreed to announce the upcoming process with a deadline for input of December 15.

<u>Work Session Topics</u> – Input to Election Committee; Budget for social media advertising; Update on the recent HOA meeting; and review proposed HOA Bill by State Delegate Hill.
