CA'S INDEPENDENT AUDIT PROVIDES POSITIVE FEEDBACK

The Independent Auditors have reviewed CA's FY-2021 financial results and were pleased with CA's results. To quote the Independent Auditors "In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of the Association, as of April 30, 2021 and 2020, and the changes in its net assets and its cash flows for the years then ended in accordance with accounting principles generally accepted in the United States of America." This is very good news. Below is the Statement of Activities from the audited financial report.


In FY-2021 CA spent \$6,121,000 for Capital Projects compared to \$15,303,000 in FY-2020. Considering the pandemic, the results are very good. CA Staff did an excellent job in keeping expenses within revenue. Note that in closing the Haven on the Lake facility CA had to take a \$4,117,000 loss (write-off). Regarding FY-2021 term debt, CA had total term debt of \$37,118,000 compared to FY-2020 total term debt of \$20,304,000.

OBCA BOARD HIGHLIGHTS

from the desk of Board Chair, Michael Golibersuch

Owen Brown's Board of Directors held our monthly meeting on August 3rd and covered multiple different topics.

- We approved a letter to the Abrams Development group regarding their proposed development for the parking lot of the Woodmere facility at 9891 Broken Land Parkway. The proposal includes building a 5,000 square foot building on the parking lot that would house two or three retail businesses and a drive thru restaurant. The Owen Brown Board of Directors informed the developer that we are concerned about several potential negative impacts of the proposed development including the aesthetics of the parkway, light pollution, traffic impact, and the potential effect on the Owen Brown Village Center and its businesses. We asked the developer to alter their plans to address these concerns and we will continue to track this development as it progresses.
- We established an Owen Brown CARES organization and appointed Ed Warner to its board. This organization will communicate and advocate regarding environmental issues relevant to our village. If you are interested in participating in this organization, please reach out to us.
- Finally, we reviewed several properties with unresolved architectural guideline violations and nominated these violations for potential legal action. We only take this step after several months of unsuccessfully engaging with the property owners to address the violations.


