## OBCA BOARD HIGHLIGHTS

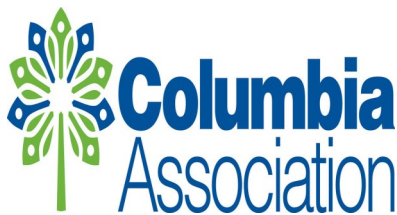
Owen Brown’s Board of Directors held our monthly meeting on November 2<sup>nd</sup>. We had one invited guest at the meeting: Jessica Bellah who works for CA on matters of public policy and zoning. She provided insight into the county process for approving individual site development plans and spoke specifically about proposed site development for two locations near Lake Elkhorn off Broken Land Parkway. Of note, she highlighted that the county planning board’s authority on site development plans is limited by zoning and regulation and that, regardless of community input (opposition or support), the planning board can only disapprove development within the bounds of their authority. The sites off Broken Land Parkway are zoned to allow for restaurants and the proposed developments can not effectively be opposed based on that usage. Ms. Bellah recommended that Owen Brown residents who want to see zoning regulations altered take part in the ongoing general plan update. Later in the meeting and keeping Ms. Bellah’s input in mind, the Owen Brown Board agreed to send a letter to the county planning board opposing the proposed Woodmere development off Broken Land Parkway and provided multiple concerns regarding trees and green setbacks, light pollution, and the placement of dumpsters.

The Owen Brown Board also discussed the three budget scenarios CA is considering using as a framework for next year’s budget. We agreed to send a letter supporting “Scenario 1” which largely maintains the status quo and avoids cuts in services likely in the other two scenarios, as well as a substantial increase in residents’ annual charge proposed in the third scenario.

Additionally, we discussed the county’s plans for placing a mixed-use pathway along Dobbin Road. When completed, this pathway will connect to the Lake Elkhorn pathway and make it much easier and safer for Owen Brown residents to walk and bike to Wegmans and other businesses along Dobbin Road. Unfortunately, the county does not anticipate completing this project for several years. Over the past few years, the Owen Brown Board has provided input to the county’s budget to advocate for funding this project.

Finally, we reviewed a property with unresolved architectural guideline violations and nominated these violations for potential legal action. We only take this step after several months of unsuccessfully engaging with property owners to address the violations. Earlier this month, on October 14, the Owen Brown Board of Directors provided testimony at the Columbia Association Board of Directors Work Session. In our testimony, we highlighted the disparity in monetary investment CA makes in the ten Columbia villages. For example, in this last fiscal year the investment CA made in Owen Brown resulted in us having an operating budget of about \$34 per person. On the other hand, investments CA made in other villages provided them as much as \$90 per person. Owen Brown’s Board of Directors does not believe this disparity is justified and we request that CA correct the disparity in their future budgets.





## SYMPHONY OF LIGHTS RETURNS TO COLUMBIA THIS HOLIDAY SEASON!

The new departments are Community Programs & Services headed by Dan Burns [*which includes Wellness and Fitness (the gyms); Sports (Golf, Tennis, Ice Rink, Sports Park, Swim Center, Skate Park); Outdoor Pools; Arts and Culture (Art Center, International & Multicultural Programs); Archives; Youth and Teens (School Age Services, Youth and Teen Center, Camps)*] and Community Operations headed by Dennis Matthey [*which includes Open Space Facilities and Building Grounds; Parks, Pathways, and Play Areas; Sustainability; Facility Services; Event Services; Real*

*Estate Services*]. Administrative Services headed by Susan Krabbe will include *Accounting; Payroll and Annual Charge (Finances); HR; IT; Purchasing; Risk Management and Financial Analysis. Communications & Marketing, Office of the President, and Board of Directors* continue as before.

The Budget build for FY-2023 is underway. If you're looking to go green with your holiday gift list, how about choosing a gift that replaces a "dirty" way of doing work with a clean and quieter solution? Why not consider buying that special someone who mows or rakes your leaves a cordless leaf blower? Or even a cordless lawn mower? Those gifts may sound a bit boring but consider how they'll make life better for you and your neighbors in terms of less noise and far less pollution. On the former score, cordless leaf blowers are quieter by far than their gas-operated counterparts; some are as quiet as home vacuum cleaners. Cordless devices, of course, are also lighter than gas powered ones and far easier to start.

But the big deal with cordless lawn care devices is how much less air pollution they produce. A half-hour of using a gas-powered leaf blower puts out as much pollution as a Ford F150 pickup truck – on a 3900-mile trip! **When you prepare your holiday dinner this year, take the simple steps below to reduce the amount of wasted food.**

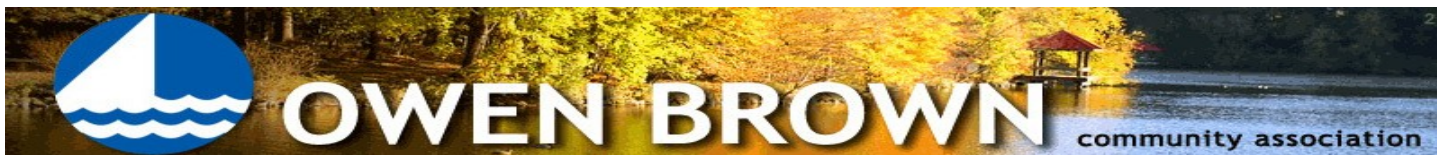
Wasted food in the landfill is a major cause of climate-warming greenhouse gas production. Here are a few simple things you can do over the holidays to cut food waste:
