#### **OBCA BOARD HIGHLIGHTS**

from the desk of Board Chair, Michael Golibersuch

Owen Brown's Board of Directors held our monthly meeting on February 7th at the Owen Brown Community Center.

We appointed three volunteers to our Election Committee: Kelly Carney, Michael Baum, and Rachel Petroff Kessler. If we have a contested election, this committee will oversee its execution. We appreciate that these individuals have taken the time to volunteer on behalf of the community.

Speaking of the election, three seats on our village board are up for election this year (the other two village board seats as well as our CA Representative are elected in even years). Candidate packets for anyone interested will be available at the community center beginning on March 1. If we end up with a contested election, remote voting will be available starting in April, with in person voting and the count taking place on April 22. Personally, I have found serving on the Board to be a rewarding experience - it has enabled me to meet many neighbors and contribute to the community in a small but meaningful way. The role of the Board and the community association is sometimes misunderstood and if you have questions about serving on the board and what it entails, please reach out to us.

We also approved updates to Owen Brown's Architectural Guidelines. We have updated the guidelines every year for the past several years to keep them in line with contemporary standards. The guidelines are written by your neighbors, and anyone can provide input. This year we received limited feedback from the community and the changes we made were largely intended to clarify existing rules rather than make substantive changes.

In support of the county's ongoing deliberation over its budget, we voted to send a letter containing recommendations for the county budget pertaining to Owen Brown. Specifically, we recommended investment in street trees, watershed management, and other green projects; continued funding for foot/bicycle/gator patrols by police in our community; funding for street renovations that should make local roads (e.g. Dobbin and Snowden River) safer for drivers, pedestrians, and cyclists; and endorsed two specific projects in Owen Brown - renovations to the fields by the library and a feasibility study for a park located at the intersection of Oakland Mills and Homespun.

Our Board is unanimous in our belief that Lakey Boyd's departure from her role as CA's President and CEO is a loss for the community. We discussed our Board's disappointment in CA's Board of Directors' inability to resolve their differences with Ms. Boyd in a mature and professional manner as well as the ongoing negative impacts the Board's behavior is having on the community. The Owen Brown Board appreciates our CA Representative's (Andy Stack) attempts to encourage the CA Board to change their course of action.

Finally, we discussed two properties with covenant violations and referred them to CA for action. We only take this step after several months of attempting to resolve the violations with the property owners.

Over the next couple months, we will be committing the remainder of this year's charitable donations budget (about \$3,000) and setting the village budget for next year. # CA APPOINTS DENNIS MATTEY AS INTERIM PRESIDENT/CEO AND WELCOMES TWO NEW BOARD MEMBERS

As you may be aware our CA President/CEO Lakey Boyd resigned in late January. In February, the CA Board chose Dennis Mattey as the Interim CA President/CEO. I believe that Dennis is an excellent choice. He has been with CA for many, many years and is known in the community. Dennis is head of Community Operations which includes Open Space. He brings a wealth of knowledge to his position as Interim CA President/CEO and he will work well with CA Senior Staff.

Historically, when CA is between Presidents, the CA Board has appointed a Senior Staff member to be Interim/Acting President. I see Dennis' appointment as a positive development as the Board worked with CA Senior Staff to identify an acceptable candidate. CA Senior Staff proposed Dennis and the CA Board accepted Staff's recommendation.

The CA Board is set to approve the draft FY-2024 CA budget on February 23<sup>rd</sup>, which is after the date this article needs to be submitted. It is a continuation budget as we are still recovering from the pandemic and dealing with inflation. The Capital Budget includes \$250,000 for renovations to Lake Elkhorn dock, pavilion, and fishing piers. It also includes \$1,300,000 for renovations to the Art Center in Long Reach, \$1,122,000 for pathway, bridges and boardwalks renovations/replacements; \$1,100,000 for building energy retrofits, watershed and water quality and "going"

green" projects; and \$1,011,000 for other Open Space projects, equipment, and vehicles.

The Operating Budget reflects full staffing for most programs and services; provides funds to cover increases in costs related to inflation; proposes to open all 23 outdoor pools this summer; adds new and expanded activities and events at Downtown Lakefront and other community venues; enhances funding to improve communications; enhances open space activities/services; and provides funds to meet the new minimum wage requirements. No long-term debt issuance is proposed. The Annual Charge Rate and Cap will remain the same as in FY-2023. In February, two new members joined the CA Board. The new representative from the Village of Kings Contrivance is Keith O'Neil, Jr. and the new representative from the Village of Long Reach is Joshua Friedman.
