### OBCA BOARD HIGHLIGHTS

from the desk of Board Chair, Michael Golibersuch

At our August meeting, the Owen Brown Board of Directors covered a diverse set of topics. We sent a letter to Columbia Association's head of Open Space providing input on maintenance around Lake Elkhorn. We also provided the CA Board of Directors input on their strategic vision for Columbia. It recently came to our attention that the architectural guidelines regarding yard signs were out of date and decided to temporarily suspend enforcement of those specific rules until we can update the guidelines with community input. While we are still open for rentals, we decided to prohibit food services at any rentals at Owen Brown Community Center until further notice as a precautionary measure as we continue to adapt to the pandemic. Finally, the board also reviewed several properties with unresolved architectural guideline violations and nominated these violations for potential legal action. We only take this step after several months of unsuccessfully engaging with the property owners to address the violations. Please ensure you maintain your yard and repair external damage to your home, fence, and deck so that your property doesn't negatively impact your neighbors' home value.

#### CA RECEIVES FY-2020 INDEPENDENT AUDIT; FY-2021 CONTINUES TO BE FINANCIALLY CHALLENGING

Each year, CA's previous fiscal year is audited by an independent auditing firm. These reports are available on the CA website. The independent auditors presented their report regarding FY-2020 to the CA Board at the end of July. To quote the independent auditors, "In our opinion, the financial statements referred to above [the FY-2020 Fourth Quarter Financial Report] present fairly, in all material respects, the financial position of the Association as of April 30,2020...". This is very good news; CA had a successful independent audit for FY-2020.

As you can imagine, with the pandemic situation, FY-2020 was not as successful as initially projected. However, CA did end FY-2020 with net assets of approximately \$1,710,000 (compared to the initial projection at the beginning of FY-2020 of \$3,804,000). Due to the hard work of CA staff, the operating budget for FY-2020 did end up positive with income exceeding expenses by approximately \$1,710,000. Overall, Capital Projects spending was reduced from \$22,890,000 to \$15,303,000.

FY-2021 continues to be challenging for CA. The first quarter financial report will be available in late September and I will discuss it in my next report.
