## *Community Vote on Rec Center Quickly Apporaches*

After years of planning and effort, the Elizabeth Park and Recreation District will be asking residents to decide whether the construction of a recreation center should be funded on May 3<sup>rd</sup>. Registered voters that live within the District will begin receiving ballots in the mail the week of April 11, and can either return the ballot by mail, or drop it off at one of the drop-off locations listed on the notice of election. The ballot initiative, titled, **Ballot Issue 6A**, asks for the District mill levy to be increased from 2.466 to 4.932 to enable the District to finance the construction costs for the facility.

The proposed recreation center, designed by BRS Architecture, is 42,000 sq ft at full build-out and includes over 7500 sq feet of aquatics space with leisrure and lap pools, a lazy river, and a hot tub, a high-school sized gymnasium, a fitness area, locker rooms, a childwatch room, a party / program room, and needed admin / storage / mechanical spaces.

# District Transparency and Public Engagement

While the District does not have the resources to ensure each resident receives every District communication, we sure wish we did. We actively strive to communicate all we can about what we are doing through our newsletter, our website, and social media platforms. The District does not employ a marketing or public relations professional, and all staff share the responsibility of public communication and outreach amongst our other duties. We always wish we could reach more people with our messaging, and will continue those efforts. Just because a resident may not have have been aware of something the District was discussing, planning, or doing, it does not mean the District was working in secet behind closed doors. Part of the responsibility of public transparency also falls on the resident, as we can put out all the information we are able, but if a resident is not tuned in to receive it, our efforts to engage only go so far. Any suggestion that the District is not transparent or is not committed to hearing from and working with residents, is just not true.

As a public agency, the District holds Board Meetings at least once per month to discuss District matters, review monthly expenditures and finances, coordinate strategic and operational plans, and decide how best to manage public tax dollars to improve the quality of life for residents. All meeting agendas are posted prior to the meeting, all meetings are open to the public, and the minutes of all meetings are posted on the District website after being approved by the Board. Any interested individual can access these resources. Prior to each of the planning processes for Casey Jones Park and the proposed recreation center, the District put out several calls for volunteers who may be interested in helping to create the vision for what each plan should entail. In doing so, the Board intentionally presented residents the opportunity to actively lead the planning process, not simply sign on afterwards to a plan the Board created behind closed doors. We want to engage, be transparent as to how and why tax dollars are being spent, and truly serve the community in the ways it desires to be served.
