District to Manage Childcare Programming at Running Creek Elementary School in 2025

Continuing its collaboration with the Elizabeth School District, the Elizabeth Park and Recreation District will begin administering and operating the Kids Club programming at Running Creek Elementary in January of 2025. Having assumed management of the Kids Club programming at Singing Hills Elementary this past summer, the District looks forward to expanding its footprint and serving more community families with much needed childcare services during "out-of-school" times. Kids Club programming includes before school care, after school care, and full-day camp like programming during school breaks and for 10 weeks over the summer season. Students are cared for and engaged in a variety of activities by our energetic staff which complements the school experience. Kids Club programming is coordinated by Tina Brisnehan, the District's Childcare Programs Coordinator. Tina brings a wealth of experience, education, and energy to the District and you can be assured that your children are in great hands under her and her team's supervision. All Kids Club programs are licensed and inspected under State of Colorado Childcare Licensing, Financial assistance is available for families in need.

Message from the Director What's Up with a Recreation Center?

I've been asked this question several times over the last few weeks, so I wanted to take an opportunity to provide an update for those that may be wondering, hoping for, or rooting against a recreation center being built in the community. Although voters did reject a ballot initiative to fund the construction of a recreation center in 2022, the Board received a lot of feedback that there were concerns with the ballot language itself and how the project was presented. The Board does believe that residents will support such a facility being funded in the future however, provided that the ballot question is clear and that it appropriately limits the project scope and spending limits.

In order to test their belief of public support for a new facility, the District will be exploring this issue during its current district wide master planning effort. As we work with our consultant team to inventory all existing park and recreation spaces and amenities, identify gaps and needs in the system, and develop priorities to be pursued, answering the question of whether residents want to fund a recreation center will be a fundamental goal. While we see and value the benefits, it really doesn't matter unless you do too.

Wherever you may stand on the issue, we hope that all residents will participate in the current master plan process and share their thoughts and opinions on whether a recreation center should be funded and built in the community. While the Board does express support, they also recognize that it is a question that needs to be presented to, and answered by residents. They respect that it is you that should decide whether funding for a recreation center is the desired use for your tax dollars.

Once the master plan process is complete next Spring, we should have a much better response to, "What's up with a recreation center?"

Youth Basketball

Do not miss out on the opportunity to register your child for our youth basketball program.

Unlike our outdoor youth sports, which are able to accommodate all youth that register within the posted registration timeframe, basketball registration will end once an age division reaches its maximum enrollment.

Maximum enrollments are set based on the number of practice days / times that we are able to secure within the schools. If you delay too long, there may not be spots available for your child to play this coming season. It's truly unfortunate, though there are just not enough gyms in the community to accommodate all youth that want to play.

Teams begin practicing in early January with the first games scheduled on January 11th. Teams practice 1-2 times per week and play games on Saturday through March 1st. Age divisions include: 6-8, 8-10, 10-12 (youth bridging two divisions should register for most appropriate division based on size and skill level). Cost is \$90/player. Volunteer coaches are needed and receive a refund for their child's fees after the season.

As the District prepares to begin managing the Kids Club programming at Running Creek Elementary, we are seeking a few all-stars to join our team. Ideal candidates should enjoy working with youth, be creative, have high energy, and be committed to providing quality experiences for local students during "out-of-school" times. We are currently accepting applications / resumes for a Childcare Site Supervisor, Lead Teachers, and Recreation Instructors. The District offers local employment at competitive pay, retirement benefits, opportunities for varied / flexible scheduling, professional development opportunities, and the joy that comes from serving your community.

Our Kids Club programs at Running Creek and Singing Hills Elementary Schools provide much needed childcare for Elizabeth families when youth are not in school. These programs include before school care, after school care, and day camp like programming during school breaks and throughout the summer. Pay for these positions range from \$15-\$23.50 per hour dependent upon education, experience, and skills. High School students may apply for the Recreation Instructor positions.

Employment is expected to begin in early Janauary, though some training may occur in mid- December.
