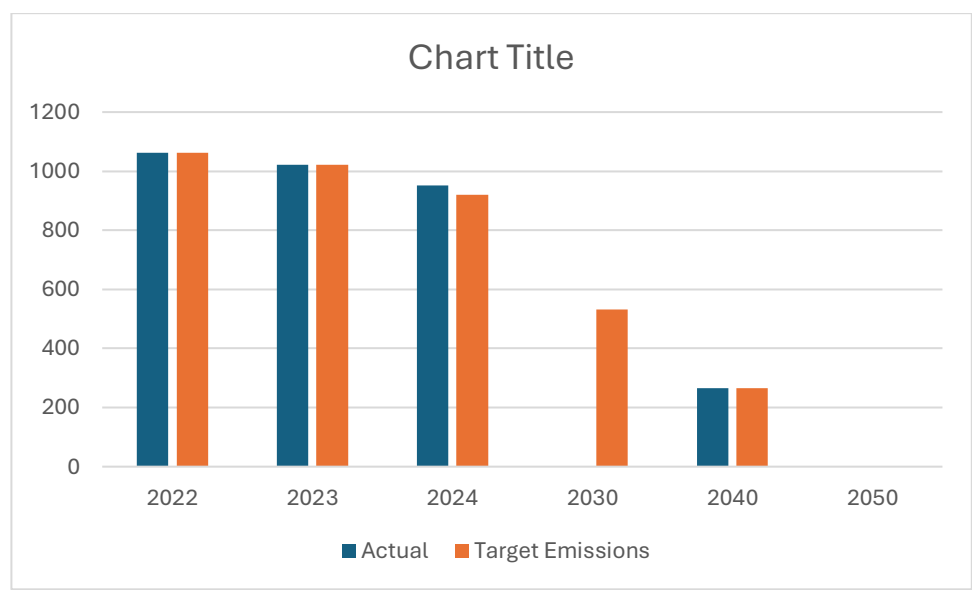
### **Emissions reduction targets**

Near Term target: JCSH commits to reduce absolute scope 1&2 by 50% and scope 3 GHG emissions from purchased goods and services, fuel and energy related activities, upstream transportation and distribution, waste generated in operations, business travel, employee commuting, use of sold products by 50% by 2030

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 650 tCO<sub>2</sub>e by 2028. This is a reduction of 40%

Progress against these targets can be seen in the graph below:



## Carbon Reduction Projects

### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2022 baseline. The carbon emission reduction from scope 1 &2 by 26% by end of November 2024, equivalent to a reduction of 0.77tCO<sub>2</sub>e. This has been achieved by increasing the amount of renewable electricity we generate on site and energy efficiency operations in the office. From scope 3 the carbon emission reduction by 10% by end of November 2024, equivalent to a reduction of 110.77 tCO<sub>2</sub>e. This has been achieved by reducing business traveling, use low emission transporters and more efficiency control with upstream suppliers.

### Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard<sup>1</sup> and uses the appropriate Government emission conversion factors for greenhouse gas company reporting<sup>2</sup>.

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard<sup>3</sup>.
