Minutes of the Parish Council Meeting of 10/02/2025

141/24 Apologies – acceptance and approval - Apologies received from Cllrs Gibbins, Pogson and Pain (retrospectively). NCC Cllr Saddington & N&SDC Cllr Melton.

142/24 Declarations of interest – no changes, Rol forms received from Cllrs Boffy and Powell

144/24 Clerk's update and received correspondence

- a) Hedge cutting to a part of the green The resident provided evidence from Bloor Homes to support their request. It was agreed that the specific hedge concerned would be added to the scope of work going forward on a permanent basis
- b) Play Area inspection Clerk advised that the cost of an inspection would be £155 but could not be carried out until May. The inspection could be expedited at a cost (Clerk to investigate and advise). To be diarised annually thereafter
- c) **Tree replacement** Clerk advised that there was an opportunity for support from N&SDC but applications were on hold until April
- d) **Consultation on standards in Public Life** It was agreed that this was a matter for individual councillors to make their own responses.
- e) Email from a resident concerning damaged fencing along the railway line It was agreed that the Clerk should approach EMR
