Minutes of the Parish Council Meeting of 19/05/2025

25/018 Clerk's update and received correspondence The Clerk advised that an appointment had been made by a Centrica subcontractor to replace the electricity meter on the Village Green on 12/6/25

An email had been received concerning parking for "Fiskofest". Further explanation and clarification was requested, Cllr. Saddington would be communicated with if appropriate.

25/019 Reports from District and County Councillors

Cllr. Melton stated that there was nothing new to report. However, he provided reassurance that the planning IT issue was non-recurring and following a question from a councillor confirmed that PC comments were indeed taken into relevant consideration by the planning committee and also pointed out the increasing pressures concerning planning and housing stock.

Cllr. Saddington voiced her thanks for her re-election and gave assurance of her ongoing commitment going forward. Cllr. Saddington reiterated Cllr.Melton's comments on planning and gave an update re current county situation, which is unclear and difficult. Councillor Saddington was now in opposition and therefore less able to give informed observations but announced that the local grant fund was no longer available.
