## PAYMENT AGREEMENT

The Applicant and the undersigned, individually, jointly and severally, acknowledges that a service charge, computed on the basis on one and one-half percent per month of all sums due to Johnstone Supply of Santa Ana / Johnstone Supply of Laguna Hills / Johnstone Supply of Long Beach which have not been paid within thirty (30) days from the invoice date, shall be charged to the Applicant. The Applicant and the undersigned, individually, jointly, and severally, agrees to promptly pay said service charges. Any controversy between the parties to enforce or interpret the terms of this agreement shall on written request of one part be submitted for arbitration.
