As we conclude another fiscal year, our board wishes to express our heartfelt gratitude for your unwavering support of our reentry nonprofit organization. Your contributions have been instrumental in our mission to facilitate successful reintegration and create second chances.

We're particularly grateful to Mayor Wu, The Office of Returning Citizens, The Office of Black Male Advancement and Attorney General Andrea Campbell for their continued backing of our initiatives. Their support has been crucial in advancing our cause. We also extend our thanks to the Small Business Administration for their invaluable assistance in empowering our team.

This past year, we've made significant strides towards our strategic goals:

- Expanded our My Successful Blueprint business and finance training program, resulting in a 30% increase in successful job placements and over a dozen clients became business owners!
- Launched our PICS program connecting our clients and loved ones with mental health professionals and resources.
- Strengthened our partnerships with local businesses and reentry organizations, creating more opportunities and resources for our clients.

Looking ahead, we're excited about several upcoming initiatives:

- Implementing a new addiction and recovery program
- Expanding our mental health services
- Developing a digital literacy curriculum to enhance our clients' technological skills
- · Launching a comprehensive legal training program to educate our clients on their rights and responsibilities
- Expanding our gun violence prevention and intervention program to address this critical issue in our community

We are kicking off FY 25 with our first fundraising event,' 3 Pounds of Pressure on October 18, 2024. All proceeds go towards our mission.

Our 3PP program aims to reduce violence through education, conflict resolution training, and community outreach. We're committed to creating safer neighborhoods and providing alternatives to violence for at-risk individuals.

We're also exploring future partnerships with local community colleges to provide educational opportunities for our clients and will continue to collaborate with Northeastern University college radio station to strengthen our relationship with the community and provide a safe space for discussions around reentry.

Your continued support is vital as we work towards these goals. Together, we can build a more inclusive community that offers second chances, promotes successful reintegration, and addresses critical issues like gun violence.
