- Register your business with the Louisiana Secretary of State, the Louisiana Department of Revenue, and the Louisiana Workforce Commission
- File amendments, such as annual reports, with the Louisiana Secretary of State


Below are the steps needed to follow in order to open a business within St. Charles Parish after completing the step above.

## 1) PLANNING & ZONING CLEARANCE

You must contact the following agency for a zoning clearance. The owner, a corporate officer, or a legal representative must complete and sign the application.

### What you will need:

- Completed application form
- Copy of lease or act of sale to property
- Fee payable to St. Charles Parish Department of Finance
- "General Inspection" report from the LA State Fire Marshal
  - Call (504) 568-8506
- Sewer verification
  - Community Sewer - (985) 783-5100
  - Private Treatment - (985) 764-4376
- Site plan showing building size and location, parking lot, loading zone, landscaping and sidewalks

### If changes or upgrades to the site are made, permits may be required:

- Sign permit
- Electrical trade permit, Plumbing trade permit
- Commercial renovation permit

### Additional Items May be Required For Some Businesses:

- Wastewater permit for any type of vehicle washing
- LA Department of Health & Hospital's Certificate for food sales (985) 764-4376
- Contract from a hazardous waste hauler for automobile repair services
- Certification from Cosmetology Board or Barber Board (225) 756-3404
- or (225) 925-1701
- Determination of locational compliance for alcoholic beverages sales

## 2) SALES & USE TAX

After receiving the Planning & Zoning Certificate of Occupancy, the owner of the business must bring the required documentation and register with the Sales Tax Office.

### What you will need:

- Planning & Zoning Certificate of Occupancy
- Driver's License
- Sales Tax Application

\*For parades, carts must put down a \$100 deposit per cart. Once the actual return is filed, either a balance will be billed or an overpayment will be refunded.

You may also register for an account, file and pay online for sales and use tax: [parishe-file.revenue.louisiana.gov](http://parishe-file.revenue.louisiana.gov)

*\*If you apply on Parish E-File and live:*

- in St. Charles Parish, you will receive a phone call or e-mail as further documentation is needed (P&Z Certificate of Occupancy and Driver's Licenses, signed & witnessed Taxpayer Responsibility Acknowledgement form)
- outside of St. Charles Parish, you will receive your account information and registration certificate, and a Taxpayer Responsibility Acknowledgment form to sign and witness via e-mail or mail.

## 3) OCCUPATIONAL LICENSE

All new businesses must contact the Occupational License Department (Tax Division of the Sheriff's Office) in order to complete the process and obtain your occupational license for St. Charles Parish.

**\*\*This License is renewable on a yearly basis\*\***

### What you will need:

- Completed Occupational Licenses Application with \$50 fee
  - After June 30th, the fee becomes \$25
  - (check or money order)
- Certificate of zoning compliance from the Planning and Zoning Department (Step 1)
- Health Permit (if applicable)
- Sales Tax registration certificate from the Sales Tax Office (Steps 2)
- If your business is Incorporated or an LLC - Provide a letter of Incorporation or Limited Liability Corporation Document

**\*\*All Occupational Licenses expire December 31st every year in St. Charles Parish\*\***

# ST. CHARLES PARISH

## HOME OCCUPATION

A business operated from the owner's home must receive approval from the St. Charles Parish Planning & Zoning Department, the Sales & Use Tax Department and the Tax Division of the Sheriff's Office.

### STEPS:

#### Apply for a permit with Planning & Zoning

- Call P&Z (ask for a Planner) to make sure your business can be operated as a home occupation.
- Local home based contractors will need to contact LSLBC (225) 765-2301, as this licensing will have to go to the Commission
- Apply for a Home Occupation Permit
- Upon receipt of the Home Occupancy Permit application, P&Z will place a sign in front of the applicant's residence, displaying the intent to operate a home-based business.
  - Administrative -- Ten (10) days
  - Commission -- About two (2) weeks prior to the meeting date

#### Evaluating the Application

- If the department does not receive negative commentary during the ten (10) day sign-posting period, the director may approve the application.
- If the department does receive negative comments, or if the proposed business fits any of the following criteria, the director will forward the application to the P&Z Commission for consideration.
  - The proposed business requires local, state, or federal agency approval of any phase of the operation (i.e., Board of Health, State Fire Marshal, etc.)

# ST. CHARLES PARISH

## HOME OCCUPATION CONT.

### What you will need:

- A completed Home Occupation Application
- Act of Sale or Deed to the Property
- A notarized affidavit from the property owner if applicant is renting/leasing; located on application
- Photos of the vehicles, trailers and equipment to be used for business
- Health Department (985) 764-4376, approval for any proposed business that handles/prepares food or beverages
- State Fire Marshal approval (504) 219-4600, for any proposed business that would have customers coming to the home
- Louisiana State Licensing Board for Contractors (225) 765-2301, for home based contractors (Electrical, Construction, A/C, etc.)
- The accompanying \$25 or \$200 fee

\*\*Upon receiving your Certificate of Home Occupation, the same steps and documentation is required for the Sales & Use Tax and Occupational License departments as stated previously.\*\*

# ST. CHARLES PARISH

## BEER / TOBACCO LICENSE

If your business intends to serve or sell alcohol, it will require a Beer / Tobacco License from both the state and local agencies. To begin this process, it is best to call the St. Charles Parish Planning & Zoning Department.

***\*\*This license is renewable on a yearly basis.\*\****

Important tips about this license:

- The proposed business cannot be within five hundred (500) feet of a public playground, a building used exclusively as a church or synagogue, a public library, a public school, or a licensed day care center, except a school for business education conducted as a business college.
  - The applicant must submit an application, signed by a registered surveyor or engineer, stating compliance with the five-hundred (500) feet rule.
- Submission of a completed and notarized Beer and/or Tobacco License application, along with the accompanying license fee.
- Publication of a public notice for two (2) consecutive weeks in the St. Charles Herald Guide.
- Outdoor Consumption requires a five (5) day sign posting period.
- Submission of a completed and notarized "Schedule A" by all managers. "Schedule A", administered by the Office of Alcoholic Beverage Control, provides detailed information on the applicant's background and documents the satisfaction of criteria and conditions listed in LA R.S. 26:79 and 279.
- Verification of United States citizenship and Louisiana residency, for the past two (2) years, by all owners and managers.
- Fingerprinting of all owners and managers.
- Submission of a completed Alcohol-Beer Operators Permit by all employees who will handle alcohol in the proposed business.

## LOUISIANA ALCOHOL AND TOBACCO CONTROL

You must contact the Office of Alcohol and Tobacco Control if you are selling alcoholic beverages. Anyone applying for an alcohol license must have a state and locale tax clearance before they will be issued a permit.
