# GMSS welcomes new board member

t has certainly been another busy month! The flooding affected a large number of people in our community, some ruinously, but we are profoundly grateful that people are safe, and for the communication, collaboration and compassion shown by our community.

Our board, now reconstituted, met in person on July 20 and appointed Michelle Streeter to serve. We are now in compliance with the requirement that 51% of the board must be people who qualify for developmental services or a family member of someone who qualifies. This is an important milestone on our path back to full designation. The board's next meeting will also be in person, at GMSS, on Thursday, Aug. 17 at 5:30 p.m. All community members are invited to attend and there will be time in the agenda for public comment. The board can be reached by email at board@gmssi.org.

We want you to stay tuned for some upcoming announcements about how we plan to restore GMSS as a part of the community for those we serve. As those who have been part of GMSS for a long time know, there was a time when we didn't work hard enough to support individuals to build meaningful relationships within their communities. We also weren't supplying our DSPs with enough resources or help. The result was that there were a lot of people hanging around the office all the time - the people we serve didn't get to experience the world as they should have, and the office was so crowded it was sometimes hard for staff to get work done. Unfortunately, rather than addressing those shortcomings constructively, a blunt 'solution' was imposed; the people we support were told that the office was not a place for them to be unless they had a meeting scheduled with a staff member. That was wrong. We should have addressed our shortcomings properly, not by closing our doors and in turn creating more problems. We are working to fix this. There is a way to make GMSS welcoming while also ensuring the people we serve are supported to experience rich, community-based lives and while also ensuring that staff can get their work done.

GMSS is part of the community, for all of us, and we want the people we support to feel welcome again once whether to schedule an activity or event, or simply to pop in to enjoy lunch with a friend in a warm, accessible place. Again, stay tuned for upcoming announcements!

Path to Full Designation - In

closing, I again am sharing the data that was sent to the Commissioner and senior DAIL leadership team in our most recent monthly report. It reflects fantastic work! GMSS is getting stronger every day.

Compliance with shared living home inspection regulations

DS – 61 Homes [97% compliance]

59 Compliant (56 fully approved; 2 housing in progress and timely; 1 accessibility in progress and timely)

2 Non-compliant (in progress but incomplete)

BI – 6 Homes [100% compliance]

6 Compliant (5 fully approved; 1 accessibility in progress and timely)

AFC – 47 Homes [98% compliance]

46 Compliant (43 fully approved; 1 housing in progress and timely; 3 accessibility in progress and compliant)

1 Non-compliant (accessibility in progress but incomplete)

#### Monthly in-home visits by service coordinator

Across all programs, 110 of the 110 (100%) people receiving residential services had completed service coordination/visit notes for the month of June.

Of the 110 completed visits, all but two were conducted in-home. One was done virtually due to the participant's extended stay in the hospital and one was completed at the individual's home but outside.

Compliance with CMS regulations for **CIR** reporting

67% (8 of 12) of the CIRS submitted to DAIL in June were submitted on time and without error. Errors identified by our QA team include:

\* one instance in which the guardian had been notified but that notification was not documented on the CIR

\* one CIR was submitted one business day late

\* one participant visited an ED but the CIR was mislabeled and was not submitted to DAIL

\* on one CIR, red ink, rather than blue or black, was used in two sections

MONITORING OF RESPITE PROVID-ERS

Random review of five notes was completed again this month and that showed service coordinators have continued to attend with care to respite oversight.

Service coordinators and SLPs have also been reminded to monitor respite utilization throughout the year to ensure that respite funds are used appropriately and will be available as needed.

Adult family care and brain injury participant reassessments

AFC – 6 ILAs were due in June and all 6 were submitted within the required time frame. All program participants have current assessments in place.

BIP - 0 reassessments were due in June. All program participants have current assessments in place.

#### INTAKE

We successfully welcomed one DS participant at the end of June. Several other applicants for intake are currently in review and we anticipate welcoming our next participant imminently. The two most notable challenges we have experienced are (1) delays in getting all the records needed to evaluate our ability to serve someone and (2) shared living providers who are surprised by the amount of training we require before we will permit a transfer from another agency and who need extra time to complete that training.

# Mold growth after a flood

Mold and mildew are general terms used to describe kinds of fungus. There are hundreds of different types of molds that vary in color and appearance. Mold is common in nature, and can also be found indoors. Mold can grow on foods, building materials, upholstery, clothes and other surfaces. If your home or building has been flooded and you were not able to dry it out within 24 to 48 hours, assume you have mold growth.

Protect yourself from mold by wearing protective clothing, including masks (N-95), gloves and goggles. Children, people with breathing problems and people with weakened immune systems should not help clean up after a flood. Use portable air cleaners with HEPA (high efficiency particulate air) filters to reduce your exposure to mold in the air. Learn how to select the right air cleaner for your home or building in the EPA's Guide to Air Cleaners in the Home (www.epa.gov/indoor-air-quality-iaq/ air-cleaners-and-air-filters-home). Have your heating, ventilating, and air-conditioning (HVAC) system checked before you turn it on to prevent spreading mold throughout your home or building.
