ear GMSS Community, Our quality improvement work continues, and we are steadily refining and expanding our efforts. What this means for the people we support is that we are more carefully monitoring service delivery to ensure that it matches participants' needs and funded supports; that all team members have the training they need to do their jobs effectively; that service plans and emergency fact sheets are current and comprehensive; and more. We are always looking at our work through two important lenses - compliance and quality. Compliance means we are adhering to rules and regulations - critical to participants' safety and welfare, and also to agency health. Quality means that we look past compliance to ask, "Are we making a positive difference? Is the person's quality of life better as a result of what we are doing?" We are very fortunate

to have Sal Acosta as our Quality Director because his decades of quality improvement leadership experience mean our ship is being

Payment reform is advancing steadily in DS services and COI (conflict of interest-free case management) will affect participants in Developmental Services, Brain Injury, and Adult Family Care. COI will introduce a new, independent case management entity to each person's team, changing the role of service coordination as we know it now. I encourage you to attend information sessions and ask questions about what this will mean

for you.
