Celebrating a one-year milestone and opportunities ahead



Dear GMSS Community –

It was one year ago that we celebrated the redesignation

of the agency, and we have had a very full year since achieving that milestone! Rebuilding the agency has taken the effort and commitment of every single member of our community and I'm grateful for each of you. We still have work to do, but we now have the skills and, more importantly, the people necessary to move forward successfully, in service to those who trust us to provide needed services.

I want to update you on significant upcoming systemic changes that will affect all of us, including those we serve. First is conflict of interest-free case management which, because that is such a mouthful, is commonly referred to as COI (see-oh-eye). COI is a federal requirement designed to ensure that individuals receiving services have their needs assessed and planned for objectively, by someone other than the agency that delivers services. This means everyone receiving HCBS services in Vermont (whether in the DS, AFC, or BI program) will have at least one new team member beginning in 2025. In very practical terms, each person who receives services will have a new, independent case manager who will identify support needs, write the annual service plan, and monitor the person's progress and welfare.

GMSS will collaborate closely with the new case managers who will depend on us to do most of the things we currently do – write behavior, communication, and employment support plans; contract with and support shared living providers; provide training to staff and contractors; monitor progress toward outcomes; facilitate and oversee healthcare; etc.

The State anticipates contracting in April 2025 with one or more new case management entities, who will serve participants in the DS and BI programs. Following a transitional period for training and other build-up activities, those new DS and BI case managers will assume their responsibilities on October 1, 2025. AFC participants will receive case management from one of the Area Agencies on Aging. AFC case management transitioning will begin in June 2025 and will be completed by December 2025. 2025 is going to bring considerable change. You can learn more by visiting the DAIL website I'll continue to provide you updates here and of course, I'm happy to answer your questions any time.

The second big change is the Developmental Services payment reform initiative. This will be a state-level transformation of how DS services are funded and how provider agencies are paid. It will have sweeping effects on provider agencies and we are working now, alongside DAIL and all the provider agencies, to achieve the best possible outcomes. You can learn more about this initiative at the DDSD website.

What else is happening now? So much, but here are some highlights

- Our 2024 training initiatives are advancing nicely! Our staff have recently received training in advance care planning as well as in fraud, waste, and abuse prevention. Our first Shared Living Provider in-service day provided an opportunity for our SLPs to talk with members of the Vermont Clinical Training Consortium about the unique privileges and challenges of the SLP role, as well as to work with our nursing team on topics including managing complex updates to medication administration records. Our second in-service opportunity is October 30 and SLPs who haven't yet met their 2024 training requirements are encouraged to attend. - Under the stewardship of Operations Director, Beth Hammond, the WheelPad project has finally gained real traction. The purchased units have all been delivered and we anticipate receiving our Certificate of Occupancy for the first two units soon.
- We continue to sparkle on our key performance indicators. This includes items such as submitting critical incident reports on time and ensuring we see people, in their homes, every month. We are excited to be expanding our list of performance indicators in 2025 as we update our Quality Improvement Plan.
