What Personal Data We Collect and Why

Contact Forms

We use our contact forms to respond to visitors who would like more information about buying, selling, or renting property. We do not give out contact information to third-party vendors, suppliers, or marketers. We offer an optional monthly newsletter, which you may subscribe to or unsubscribe from at any time.

Cookies

If you leave a comment, you may opt in to saving your name, email, and website in a cookie for convenience on future comments; these last one year. If the Site has a login area, a temporary cookie may be set to check whether your browser accepts cookies, and additional cookies may be set on login to save your session and display preferences.

Embedded Content

Pages on the Site may include embedded content (e.g., videos, images, or MLS/IDX listing widgets) from other websites. Embedded content behaves as if you visited the other website directly, and that site may collect data about you, use cookies, and monitor your interaction with the embedded content.

Who We Share Your Data With

We use the information you provide only to help you with your real estate needs and do not share it with others unless disclosed to you in advance. We work with third-party sites where you may access mortgage or other services; please review their privacy policies separately.

How Long We Retain Your Data

If you leave a comment, the comment and its metadata are retained indefinitely so we can recognize and approve follow-up comments automatically. If you register on the Site, we store the information in your user profile, which you can view, edit, or delete at any time (except your username).

What Rights You Have Over Your Data

If you have an account on the Site or have left comments, you can request an exported file of the personal data we hold about you, and you can request that we erase personal data we hold about you, except data we are required to retain for administrative, legal, or security purposes — including records real estate brokerages are required to retain under state licensing law.

Analytics

We use MonsterInsights via Google Analytics, through WordPress/GoDaddy, to measure site traffic and advertising performance.

How We Protect Your Information

Your personal information is contained behind secured networks and is only accessible by a limited number of people with special access rights who are required to keep the information confidential. Sensitive information you submit is encrypted via SSL. Payment transactions, if any, are processed by an external PCI-compliant payment gateway and are not stored on our servers.

We use a security plugin to provide activity auditing, remote malware scanning, and security hardening, which checks for malware, spam, blacklisting, and other security issues.

Third-Party Disclosure and Links

We do not sell, trade, or otherwise transfer your personally identifiable information to outside parties, except to website-hosting partners and other parties who assist in operating our business and agree to keep the information confidential, or as required by law. The Site may occasionally link to third-party products or services; those sites have their own privacy policies, and we are not responsible for their content or practices.
