## **Digital Millennium Copyright Act (DMCA) Notice**

3. An address, a telephone number, and an e-mail address where The JMR TEAM can contact you;
4. A statement that you have a good-faith belief that the use is not authorized by the copyright or other intellectual property rights owner, by its agent, or by law;
5. A statement by you under penalty of perjury that the information in your notice is accurate and that you are the copyright or intellectual property owner or are authorized to act on the owner’s behalf;
6. Your electronic or physical signature.

The JMR TEAM may request additional information before removing any allegedly infringing material. In the event The JMR TEAM removes the allegedly infringing materials, The JMR TEAM will immediately notify the person responsible for posting such materials that The JMR TEAM removed or disabled access to the materials. The JMR TEAM may

also provide the alleged infringing party with your e-mail address so that that person can respond to your allegations.

The JMR TEAM reserves the right to terminate, limit or suspend any user's access to the Site in the event of repeated infringing activity. If you believe that a user of this Site is a repeat infringer, please follow the above instructions to contact The JMR TEAM 's Copyright Agent. Please include sufficient information to assist The JMR TEAM in determining that the user repeatedly engaged in infringing activity.
