Have an offer on the land of \$20,000 and increased to \$25,000, the attorney rejected the offer as it is appraised at \$78,000. Next meeting is this Thursday. The road improvements have been coming along good, Birch Bay will work out, FEMA measured incorrectly, and s/b 12' more on the West Lake Miltona Road. Richard will add 6' to each side. Gary marked ditch past Tamarac Circle on new house to remove the material dumped in the ditch.
