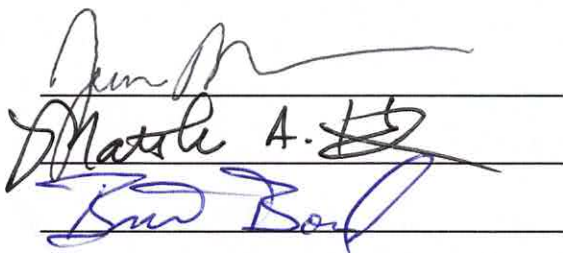

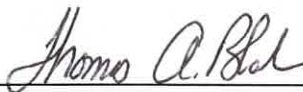

A motion by Matt, second by Brent to adjourn, motion carried 2-0 7:45 pm.

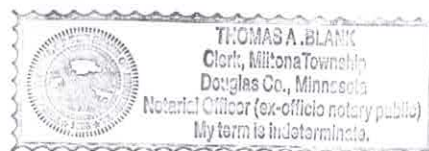

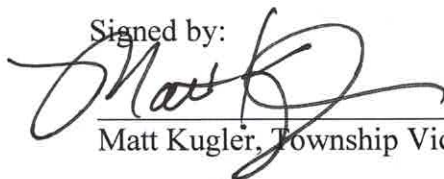

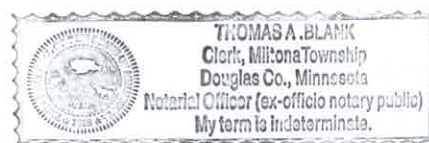

WHEREAS, this being an election year for an August Primary and November General election, and

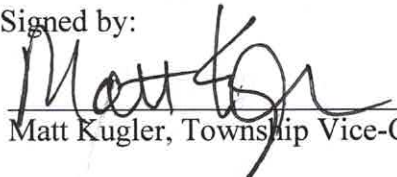
WHEREAS, election judges candidates have completed their required training, and

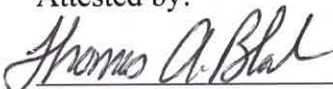
