Re: Agency Review for Proposed Ainsworth Community Park Project in Thompson Falls, MT

Dear Mr. Cullooyah:

The City of Thompson Falls is proposing to build a park at the northwest intersection of Maiden Lane and Lincoln Street, just south of W. Main Street (Hwy 200). The project is located in Government Lot 6 of Section 7 and Government Lot 4 of Section 8, T21N, R29W, P.M., M, City of Thompson Falls, Sanders County, Montana (see vicinity map below). The proposed Ainsworth Community Park will serve as the keystone park in the City's urban system and will include a pavilion with restrooms along with an amphitheater. This park will be capable of holding events, concerts, and family gatherings. Its presence is expected to increase the number of events downtown, stimulate economic activity and contribute to the community's sense of place.

A preliminary engineering report (PER) was prepared in October 2017 and followed the requirements of the Uniform PER for Montana Public Facility Projects to assist with obtaining grant funding for construction of the project. The City of Thompson Falls obtained CDBG grant funding

earlier this year, and we are now requesting comments from your agency as part of the Environmental Assessment (EA) requirements associated with this project.

This project entails creating a public park on an underutilized City-owned parcel in downtown Thompson Falls (see Figure 2), located within the downtown Thompson Falls Main Street corridor, just a block away from the Clark Fork River. The property was historically used for athletics and then as a baseball field, but those features were removed in 2012.

The timeline associated with this project is to complete final design in 2018 and construct in 2019. The project entails the construction of a new covered pavilion building, an amphitheater, and a trail system connecting existing Thompson Falls park trails. This will include utility extensions to the property including electrical, water, and sewer. All proposed construction will take place in areas previously developed; primarily on the park property and in City right-of-way. A conceptual drawing of the park is enclosed with this letter, and a 3D rendering of the project can be seen below in Figure 3.

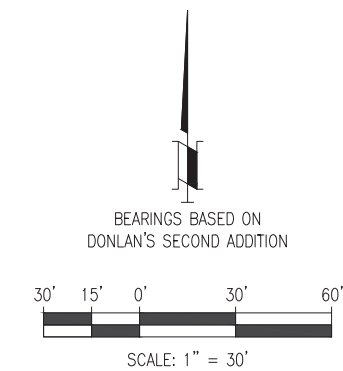
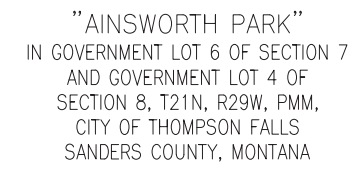
