## Hogs, Lambs & Goats

Pre-Entry information for the 2025 Show  
Dates for Show are April 9 Thru 13, 2025

**This is a TERMINAL show, all animals that go through the sale will be taken from the sale directly to our processor, NO EXCEPTIONS.**

**Hogs** MUST be owned & be in your possession on or before January 20, 2025, **not born before September 25, and not weigh over 150 lbs. when tagged in January.** (Minimum show weight is 225lbs, maximum weight is 285lbs)

**Lambs and Goats** MUST be owned & have in your possession on or before February 1, 2025.

**Lambs** (Minimum show weight is 105lbs, maximum weight is 160lbs)

**Goats** (Minimum show weight is 60lbs, maximum weight is 120lbs)

1. Pre-Entry for **hogs** must be completed **online** and payment with a copy of the online entry returned to the address above by January 30<sup>th</sup>, 2025.
  - a. Pre-Entry for **lambs and goats** must be completed **online** and payment with a copy of the online entry returned to the address above by February 1<sup>st</sup>, 2025.
2. \$5 per head tag fee MUST be sent in with the print out of the online entry. Please make check payable Northwest Junior Livestock Show. Entries without payment will be rejected/returned.
3. You may pre-tag up to 4 head of livestock per exhibitor (combined total of all livestock). This year you will be able to tag an extra animal per family, Club or Chapter at the same location in case one does not make it to the show. Must be tagged at tagging time. Only 2-head will be allowed on Official Entry form. Only 2-head will be allowed to cross the scale in April. All livestock must be pre-entered and pre-tagged to attend our show in April.
4. Hog Leaders/advisors/parents will certify that the hogs have been timely and properly tagged and return the enclosed signed certification to the NWJLS by February 1<sup>st</sup>, 2025.
5. Final Entry will need to be confirmed online this year. You will have to go back into the online entry site, from our website [www.NWJLS.com](http://www.NWJLS.com) and confirm your entries and make sure you have entered showmanship, posters, record books etc. Final/official entries will be due by March 15<sup>th</sup>, 2025.
6. Leaders/advisors/parents will be provided tags, and taggers if needed, by the NWJLS. We ask that you tag the animals and return a picture of the exhibitor with the tagged animal. This will be strictly enforced. Pictures will be due with 2 weeks of receiving the tag(s).

Please note that the pictures must show each animal with its tags in place and with enough of the animal captured in that picture that it can be fully identified and matched to the photograph. Our goal with this part of the rule is to ensure that the animal tagged is the one exhibited at the show. Also, all hogs must show up at the fair with **both** tags intact; absent prior arrangements with the NWJLS. Lambs and Goats must also have their scrapie tag. Hogs must also have the required USDA tag.

The tagging rules set forth in this letter supersede any conflicting tagging rules in the NWJLS exhibitor book. All rules in the exhibitor book, on all pre-entry forms and on all other letters/documents the NWJLS has issued for the 2024 NWJLS event are still in full force and effect, apart from the rule changes set forth in this letter. Of Course, failure to comply with any rules, including those set forth in the letter, will subject the exhibitor(s) who do not comply to the sanctions or penalties specified in the NWJLS rules/regulations.
