- 1. Call to Order @ 11: 15 am

- 3. Introduction of Guests John Campbell from Moms Transit, Shelby Jewell from Cimarron Transit, Devan Westbrook from ODOT, he is our regional ODOT representative.
- Approval of January minutes I sent out the minutes with the agendas last month, so I need approval for the January Minutes. Amy was 1st and Tina is 2nd. January Minutes have been approved.
- 5. CORTPO has officially signed our contract with ODOT to build a Mobility Manager. Attached is the job advertisement that will go out in March. Hopefully we will get some good applicants so we can get the office running by May. I was finally able to get with Olivia and we signed our contract with ODOT for our Mobility Management Program. I have sent out advertisements for the position and have received several resumes, but they barely meet the minimum requirements for the job. I'll keep them just in case the other positions we have open at COEDD would like to look at them. I'm really hoping to get someone in and trained so the

Their program has been going for a little over a year so they have a more established outline of what is required. That will help our new Manager understand more of what they are required to do. - 6. I sent out a draft map of the Regions transit areas, can you edit it and send it back. I have also been in contact with our AAA department of which communities have senior programs with transportation and waiting to hear back from the Veterans on their transit. Are there any additional organizations that I could reach out to that I haven't yet? I did get some updates on our transit areas. I would like to get the map completed by the time the manager gets started. I have been in contact with the Veterans transits in all the counties except Pottawatomie and Lincoln so when we get back to the office, I will reach out to them again. I would like to have an in-person meeting with them to see how they transport, when, and where. I have also been working with our AAA at COEDD on the senior centers that transport. Wendy, I do have you in a larger bubble since you go in all areas, is that ok. Wendy Rutter Honey I will go anywhere.
- 7. Since we last met, I have been able to attend the Southwest Transportation Association and the Tribal Transportation Commission meeting. I was able to speak with many Tribes/Nations that I haven't had contact with before. It is my hope that we will have better communication in the future. I was able to go this meeting and talk with the tribes that I haven't been able to communicate with. I will have a CPN representative coming to our meetings starting in May and they have a large transit program. I'm really looking forward to having them on board. I was able for the first time to go to the SWTA conference and had the ability to meet with other mobility managers and transit organizations. It was a great conference and I learned so much that we can implement in our mobility program. I can't say enough about how great the conference was.

Clorisa- OK well we may or may not have it all done by May, its



according to when we get the budgets from ODOT. But I can go ahead and send the updated manuals out and do their public comment period in June. I know the Mobility Program said that they will have the budget for us by the end of May so that will be a special meeting in August. Everything must be turned in by the end of September. October is the beginning of the fiscal year for us. Does anyone have any comments or suggestions? no
