This agreement is made between Jessica (coastal country farms) and _____ (buyer/owner). This agreement is governed under the state of Washington.

At the time of this agreement a \$350 deposit is required to be paid by the buyer, this deposit is nonrefundable if the buyer backs out for any reason but is refundable if for any reason the puppy is considered "unadoptable". Remaining balance is due at 8 weeks of age (if holding past 8 weeks) or at time of pickup.

Health Guarantee

The puppy is in good health and free of communicable diseases at the time of this sale. This puppy is covered by a 3-year genetic health guarantee

This Guarantee does NOT cover Cherry eye, Entropion, Ectropion, Allergies, undescended testicles, loose knees or hips, hernia, dermatitis, demodetic mange. Seller will NOT replace a puppy due to heat stroke, abuse/neglect, or improper socialization. During traveling, puppies can become stressed by the change in environment. Minor problems such as diarrhea, coccidiosis, upper respiratory, kennel cough etc. These are the responsibility of the buyer not covered under the health guarantee, giardia, any condition that is non genetic, or is due to environmental issues, or can be cured with medication will not be covered by this guarantee. Breeder does guarantee all puppies will be "nonaffected" (carrier or clear) for DM, EIC, PRA, And Type 1 VWD as parents are always genetic tested prior to breeding.

Seller does not provide any warranty as to the Dog's fitness for any specific purpose, including obedience trials, show ring performance, and/or breeding purposes.

Your puppy is guaranteed until three years of age against fatal and life altering congenital diseases. This includes hip dysplasia, which hampers a dog's movement and requires surgery to correct. Heart and liver problems of a severe life threatening or altering nature are included. In the unlikely event that this occurs, breeder must be notified within 48 hours of the licensed veterinarians' determination, by phone. At buyers' expense, breeder will need to be sent report from licensed veterinarian stating the health concern/diagnoses.

A returned puppy must be returned to seller in good condition, other than the specific problem with all paperwork and veterinary records. In the unlikely event that a puppy should die within the one-year time frame, the buyer, must pay to the the puppy autopsied, to show reason of death. The autopsy must show without any doubt the cause of death was a congenital problem, for a replacement puppy. Breeder will only replace a puppy, with a puppy from the next available litter. No monetary refunds will be given. The replacement puppy may or may not have the same parents, puppy must be of equal value. This health guarantee is non-transferable. Buyer agrees that all expenses incurred after transfer from the breeder are the buyer's responsibility and will not hold the breeder liable. Buyer agrees to get the puppy examined by a licensed veterinarian within 48 hours of picking up the puppy, buyer understands puppy needs more vaccinations, and dewormer after picking up and will not hold breeder liable for these expenses.

This puppy is being sold with FULL rights, meaning buyer is able to breed the puppy when he/ she reaches an appropriate age. Buyer agrees to breed the dog ethically and ensure all puppies produced are placed on contracts with limiting full rights to select breeders who are ethical.

Buyer agrees to have "CCF" at the beginning of the dogs name for registration paperwork.
Buyer agrees to ensure that all puppies produced from this dog are placed on contracts.
Buyer agrees to not inbreed the dog.
Buyer agrees to not Merle to Merle breed. (If dog is Merle)
Buyer agrees to not breed a "carrier" to a "carrier" if the dog is a carrier of a genetic condition
