Construction scheduled to commence: On or after June 17, 2024 Construction scheduled to be completed: On or before July 31, 2025


Project Overview

The City of Mississauga will be constructing new retaining walls to support a multi-use trail at the north side of Dundas Street West at the following locations:

- (1) between Erindale Park Entrance and the Credit River, and
- (2) between Robinson Street and Dundas Crescent.

Please note, shifting of vehicle lanes will be required between The Credit Woodlands and Mississauga Road to maintain two westbound lanes and two eastbound lanes on Dundas Street West during construction. The middle turning lane will become unavailable throughout construction. The left turning lane at Credit Woodlands and Mississauga Road will be maintained. Please reduce speed and follow the traffic signage.

The successful contractor for this project is Rafat General Contractor Inc. The project is part of the Council-approved 2024 Capital Works Program.



Work Details

The City Contractor's work entails the following:

- Conduct a pre-construction structural survey at selected buildings. A City Representative will contact property owners directly to make an appointment for the survey.
- Relocation of streetlighting poles and protection of existing utilities.
- Implementation of erosion and sediment control measures.
- Clearing and removal of tree stumps, shrubs, and existing sidewalks.
- Installation of temporary shoring system and auger caissons.
- Excavation and backfilling earthworks.
- Installation of new retaining walls and multi-use trails.
- Planting of trees and shrubs to restore the landscaping.
