All applications must be filled out completely, signed, dated, and adhere to the timeline spelled out in the city code to be considered complete.

City Code:

- The cemetery superintendent shall be given 24 hours' notice, excluding Sundays and Holidays, in warm weather months (April 1 November 30) for the opening and preparation of the grave prior to internment.
- The cemetery Superintendent shall be given 36 hours' notice, excluding Sundays and Holidays, in cold weather months (December 1 – March 30) when the ground is frozen, for the opening and preparation of the grave prior to inurnment. (Ord. No. 1161, 3-12-2018)
