- c. Mares on the premises of HD Performance Horses have breeding priority on any given day, therefore, we make no guarantee cooled semen will be available for any specific day. In the event of insufficient semen on a particular breeding day, HD Performance Horses will ship on a first ordered, first served basis.
- 6. Registration Papers: A copy of the Mare's registration papers is required with the signing of this contract. The Mare Owner agrees that the Mare shall be in sound breeding condition and free from infection or disease. A negative uterine culture is recommended for maiden and open mares prior to the shipment of semen.
- 7. Semen Shipment: Shipping days beginning of February 2<sup>rd</sup> Monday, Wednesday, Fridays

- a. Your veterinarian/mare manager must call HD Performance Horses (515-238-9453) or email (Hd.showhorses.mgt@gmail.com) <u>the day prior</u> to the collection day by <u>5 pm</u> (CST) to place the mare on the shipment request list.
- b. Orders must be confirmed or canceled by 8am (EST) on the collection day. Cancellations made after that will be subject to a \$100.00 cancellation fee.
- c. On occasion there may be insufficient semen to fulfill all semen requests. Priority will be given to on-farm mares and those mares deemed "most likely to settle" on this date as determined by information provided by Mare Owner's veterinarian or breeding technician.
- d. HD Performance Horses only assumes responsibility to ship semen in viable condition and shall not be held liable for contamination of semen during and after shipment, loss of viability, or any costs arising from shipments delayed, damaged or lost in transit. Every effort should be made to inseminate the mare within 24 hours after the collection from the stallion.
- 8. Shipping Container: The Mare Owner is responsible for returning the container to HD Performance Horses at the Mare Owner's expense via Federal Express or USPS. There will be a \$25 per day late fee charged on all containers not returned in the allotted time of 72 hours.
- 9. Live Foal Guarantee: Stallion Owner guarantees that a single live foal will result from the breeding privileges granted herein. The term "live foal means that one foal resulting from the breeding stands alone, and nurses. It is understood that if the Mare proves barren, aborts her foal, or if the foal is stillborn, a return breeding will be guaranteed the following year only, providing proper notification is given as defined below:
  - a. Written certificate by a licensed veterinarian within 48 hours that the Mare absorbed aborted, or produced a non-viable foal.
  - b. Mare Owner verifies in writing that such abortion or death did not result from any act or omission on the part of the Mare Owner.
- 10. Multiple Foals: It is agreed to by the Stallion Owner and the Mare Owner that only one foal will be registered for each breeding that is secured with this contract and that the semen received will only be utilized on the Mare named above. It is the intent of the Stallion Owner that only one mare per Contract be inseminated with transported semen. When utilizing Embryo Recovery and Transfer, should more than one embryo result from a breeding, Mare Owner agrees to pay an additional Breeding Fee (\$1000.00) upon confirmation of a 45 day pregnancy in order to receive a breeding certificate for additional foals. If multiple foals from the same mare in the same breeding season will require a separate contract & Breeding fee for each resulting foal. Only except to this would be twins that are carried throughout term and foaled by the mare listed above. Mare owner would be responsible for an additional Stallion fee.
- 11. Rebreeds: If the mare does not produce a live foal the first breeding season, the mare owner is entitled to a rebreed the following year. Fees will apply as detailed in section 2. If the mare owner fails to return the mare for breeding season following the initial contract, then the right to rebreed is cancelled and the stallion owner is released for further obligations.
- 12. Substitutions: If the Stallion dies, is sold or becomes unfit for service during the breeding season, and the Mare is not in foal, this agreement shall become null and void. The Breeding Fee (Less the Booking Fee), if paid in full, will be refunded to the Mare owner only if the Stallion dies AND the Mare proved barren or does not produce a live foal. For no other reason than the Stallion dying will money be refunded. If the Mare dies or becomes unfit for service, another mare may be substituted only upon agreement modification by both the Mare owner and HD Performance Horses.
- 13. Post insemination checks: The Mare Owner agrees to have the mare checked by ultrasound no later than 18 days after insemination. If ultrasound is unavailable, Mare Owners agrees to have the mare checked for pregnancy by a Licensed veterinarian within 34 days of insemination. Mare owner agrees to provide HD Performance Horses with the results of the pregnancy exam within 35 days of insemination.
- 14. Litigation: Any litigation that may result from this contract must take place in Polk County, Iowa. Mare Owner irrevocably and unconditionally submits to the personal and subject matter jurisdiction of the state of Iowa. All objections to venue are waived.
- 15. Waiver of Liability: Neither HD Performance Horses nor their employees, officers or veterinarians shall be held liable and shall be released and held harmless from any and all claims, causes of actions, expenses and damages of any nature resulting from or relating to any escape, accident, injury, sickness, disability and/or death of mare/ or foal as well as any exercises of judgement by the release parties in connection with the custody and care of the mare and /or foal.
- 16. Liquidated damages: Should any dispute arise that is not otherwise governed or covered by a provision in this contract, including but not limited to, a dispute alleging that HD Performance Horses has breached this

Breeding Contract, the parties hereby specifically agree that damages, expenses, costs and fees including attorney's fees for such dispute, whatever the nature of the dispute, shall be limited to the sum of \$2500.00

17. Contract: this contract represents the entire agreement between the parties. No other agreements or promises, verbal or implied, are included unless specifically stated in this written Contract. Additional agreements must be individually initialed by the parties. When Mare Owner and HD Performance Horses sign this Contract, it will be binding on both parties, subject to the above terms and conditions.
