GENERAL TERMS AND CONDITIONS

1. **Member duration.** Membership to the Italian Chamber of Commerce in the Philippines (Camera di Commercio Italiana nelle Filippine Inc.) is applicable for 1 year (365 days) from signing of the present agreement. It includes the advantages, activities and events as listed herein (attached).

2. **Member requirements.** A company shall be considered as a full-fledged member of the Italian Chamber of Commerce in the Philippines upon completion and submission of the following documents:

- Duly accomplished and signed membership subscription form
- Proof of payment (T/T bank-transfer or check)
- High resolution copy of the company/business logo in .jpg or .png format

3. **Member process.** The applicant shall be informed of the status of their application within two (2) working days upon submission of the above-mentioned documents together with accompanying check covering the membership fee. Once the application has been confirmed, the new member will be informed of the acceptance of the application and if no T/T transfer is made, the check will be encashed. Benefits and privileges will apply once these fees have been cleared and credited to ICCPI.

4. If the performance by either party of any of its obligations under this Agreement (other than an obligation to make payment) shall be prevented by circumstances beyond its reasonable control, then such party shall be reasonably excused from performance of that obligation for the duration of the relevant campaign, event, project or mission without penalties.

5. Shall the project, event or mission, for any reason, be postponed, canceled or relocated to a different venue then the present agreement shall be carried forward and all rights and grants shall be valid as herein agreed. At the same time this shall not give the sponsor the right to withdraw from his obligations or to breach this agreement.

The liability of either party for any breach of this Agreement, or arising in any other way out of the subject-matter of this Agreement, shall not extend to loss of business or profit, or to any indirect or consequential damages or losses and in any case, will never exceed the principle amount of the present agreement.

8. This Agreement constitutes the entire agreement of the Parties on the subject hereof and supersedes all prior understandings and instruments on such subject. This Agreement may not be modified other than in writing and executed by duly authorized representatives of the Parties.

9. The proposed marketing plan and its performance may be subject to change. Amendments shall in no way constitute reason for breach, termination or claim against ICCPI, the main event organizer, it's event partners or contracted event organizer (if different).

10. This Agreement shall be governed by and construed in accordance with the laws of the Republic of the Philippines, without giving effect to any choice of law or conflict of law provisions. The Parties consent to the exclusive jurisdiction and venue in the courts of Makati City.
