- 1. Requests for accommodation must be made when registering and in writing to doug@ssft.ca with the words "Accommodation Request" in the subject.
- 2. A non-refundable deposit is due within 24 hours of registration to reserve your spot (The amount is on our website).
- 3. Within 10 days of class starting we will allow rescheduling only for life impacting events and course fees are non refundable. If the Authorities reinstate the Vaccine or Mask Mandate and you are unable to meet these requirements you will be allowed to reschedule once the mandate is lifted but a refund will not be provided.
- 4. The signatory acknowledges that Physical Distancing and Masking is no longer required, and students will share a 10-foot-long desk with three other people. Hand sanitizer will be provided for use.
- 5. Signing this form acknowledges you have read our FAQ at: https://smartshotfirearmstraining.ca/faq
- 6. You acknowledge you will be handling dummy ammunition with bullets made from Lead. You should wash your hands before eating/drinking.
- 7. Courses may be rescheduled for reasons including, but not limited to: insufficient enrolment, fires, floods, illness, public emergencies.
- 8. In the event of a shutdown due to Government Lockdown or Instructor Quarantine, this class may be rescheduled. This is true even if the shutdown was not in place during this class period but was of sufficient length that Smart Shot Firearms Training, in order to be fair to all participants, and at its discretion, must reschedule all remaining courses. No refund will be available in this situation.
- 9. Class and exams are conducted in English. A French written exam is available with 21 days notice but the practical exam will be in English only
- 10. The CFSC & CRFSC have written & practical exams requiring an 80% to pass. Attendance in class is not a guarantee of a passing grade. A re-test can be completed for a fee of \$67.80, including tax, per course. All re-tests must be done within 30 days. If a failure occurs on the re-test then you must retake the course before another attempt. Depending on availability of exams, the re-test may be done on the same day or scheduled for a later date. If doing the retake on the same day, you will need to wait until all other students have completed both of their exam before doing your retake. This will be added to the time you are in our facility.
- 11. You must pass the CFSC prior to taking the CRFSC. Completion of the course does not guarantee you will receive a Possession and Acquisition Licence (Firearms Licence). An application for a firearms licence must be made to the RCMP.
- 12. No Firearms or Ammunition are to be brought in the class by any Participant.
- 13. Any Participant mistreating another or suspected of being intoxicated in anyway will be asked to leave at the sole discretion of the Instructor.
- 14. A Participant who arrives late may be required to reschedule at the sole discretion of the Instructor.
- 15. Government ID is required and will need to be Photo ID. If an exception to Photo ID is required, please call 10 days prior to class to make arrangements.
- 16. The participant acknowledges that discussions around the politics of firearms may not occur during the course.
- 17. The Participant indemnifies Smart Shot Firearms Training and its affiliates, employees and representatives from any liability arising from attending this class or obtaining a Possession and Acquisition Licence (Firearms licence).
- 18. Anyone disrespectful or not acting according with the rules will be asked to leave at the discretion of the Instructor. No refund will be issued

## **Additional Requirements due to COVID 19**

- Participants will be required to completed a COVID 19 screening daily and will be rescheduled if responses indicate a COVID 19 risk.
- Please bring your own mask that covers your nose and mouth
- Participants will need to use hand sanitizer before handling any equipment
