- Requests for accommodation must be made when registering and in writing to doug@ssft.ca with the words "Accommodation Request" in the subject.
- Local By Laws require a mask will be required to be worn in class, even while physical distancing. If you require an accommodation then the Firearms Education Service of Ontario will work with you to find an Instructor and location that can accommodate the requirement.
- You acknowledge that physical distancing will not be possible during practical handling and that you will be handling disabled firearms and disabled ammunition that others have handled as well. Students will use Hand Sanitizer before handling. The signatory accepts any risks from this activity.
- The Firearms Safety Education Service of Ontario's "PARTICIPANT ACCEPTANCE AND ACKNOWLEDGEMENT FORM" constitute a part of this document.
- A \$100.00 non refundable deposit is due at registration to reserve your spot. You may also pay the full course enrolment at this time.
- Class and exams are conducted in English. A French written exam is available with 21 days notice but the practical exam will be in English only
- Within 10 days of class starting **we will allow rescheduling only for life events**. Please ensure you have no scheduling conflicts before enrolling.
- Courses may be rescheduled at the discretion of the Instructor for reasons including, but not limited to: insufficient enrolment, fires, floods, illness, public emergencies. In this case three alternative dates will be offered.
- The CFSC & CRFSC have written & practical exams requiring an 80% to pass. Attendance in class is not a guarantee of a passing grade. A re-test can be completed for a fee of \$67.80, including tax, per course. Depending on availability of exams, the re-test may be done immediately or scheduled for a later date. All re-tests must be done within 30 days. If a failure occurs on the re-test then you must retake the course before another attempt.
- You must pass the CFSC prior to taking the CRFSC.
- No Firearms or Ammunition** are to be brought in the class by any Participant.
- Any Participant mistreating another or suspected of being intoxicated in anyway will be asked to leave at the sole discretion of the Instructor.
- A Participant who arrives late may be required to reschedule at the sole discretion of the Instructor.
- Government ID is required and will need to be Photo ID. If an exception to Photo ID is required, please call 10 days prior to class to make arrangements.
- The Participant indemnifies Smart Shot Firearms Training and its affiliates, employees and representatives from any liability arising from attending this class or obtaining a firearms licence.
- Anyone disrespectful to the facility or not acting according with the facilities rules will be asked to leave at the sole discretion of the Instructor.
- Completion of the course does not guarantee you will receive a firearms licence. An application for a firearms licence must be made to the RCMP.**

Additional Requirements due to COVID 19

- Participants will be required to completed a COVID 19 screening daily and will be rescheduled if responses indicate a COVID 19 risk.

- Participants will need to use hand sanitizer before handling any equipment
