
CONSTITUTION CHANGES; Article V – Officers

Section 1. The administrative affairs of this Post of the American Legion Shall, except as may be otherwise provided by the By-Laws, be under the supervision of an Executive Committee which shall consist of all Post Officers, plus three additional Executive Committee members at large. ----

BY-LAWS CHANGES

Article I

Section 2. The Executive
Committee shall consist of all
officers of the post plus **three**additional Executive
Committeemen. - - - - - - All
elected officers and the **at large**





executive committeemen (3) shall be by ballot, show of hands, or acclimnation - - - - - -

Article III --- Post Executive Committee

Section 4. The Executive Committee shall authorize all other designated accounts for the purpose of transacting Post busnines. The chairperson of each program shall maintain their checkbook for their specific program/account. Each program shall chair shall provide monthly expense and income totals to the Post Finance Officer. Each account chair or desingee is authorized to sign required checks. The Post Finance Officer shall receive monthly totals from each chair and maintain the combined financial books for all Post programs. Surety bonds will be provided by the Post in such a sum as shall be fized by the Post Executive Committee.

Article IV—Duties of Officers

Section 1.----- The
Commander may choose to
authorize the Finance Officer
to disperse up to \$150.00 per
item whithout approval of the
Executive Committee for the
general maintenance of the
post financial affairs and notify
the Executive Committee by Email of said action. ----

Section 4. - - - - The Finance
Officer shall sign all checks
distributing the moies of the
Post, and shall furnish such
surety bonds in such sum as
shall be fixed by the Post. - - -

When you review the above changes be advised that those changes in **GREEN** are additions to our present Constitution and By-Laws Third Edition August 2020. Those in **RED** ae being deleted from this document.





<u>Post Member of the Month</u> Rondall Brown

ROGER I. ELLIOTT

He was fresh out of high school and deliberating all the choices of life to chart his course among the stars, contemplating his destiny, when his Uncle Sam. delivered an irresistible invitation for him tour the world. Roger is a real live, bonified, native of Clay County. Born and Reared in Oak Forest Community, he has resided in the county all his life until his invitation to see the world. courtesy of the U.S. ARMY in 1969. Roger departed the beauty of the Blue Ridge Mountains for the hot flat land of Georgia. FORT GORDAN, to be exact, would be his home for Basic Training and the heat was iust a precursor for what lav before him. The Vietnam War was hot with death and dying along with the miserable climate that would plunge him into an unforgettable lifetime experience. Fort Gordan was originally established in WWI northeast of Atlanta and later move near Augusta, GA. During the Vietnam War, Fort Gordon was home to Camp Crockett, an area of the post conducting 9-week advance airborne infantry training courses for soldiers in line to attend the remaining 3 weeks of Airborne training at Fort

Benning. During the 1950's and into the 1970's Fort Gordon served as a basic training facility under the U.S. Third Army. Roger would depart from Fort Gordon to lovely Fort Monmouth, NJ. to train in communication, operating microwaves equipment with an MOS of 26V20. Fort Monmouth has a long and rich history from WWI to its closure in 2011. Fort Monmouth was sometimes referred to as the "Soul of the Signal Corps". It housed the official Time Capsule of the Army Signal Corps until June 21, 2010. The Fort also hosts the Avenue of Memories, a set of trees and monuments dedicated to Signal Corp soldiers who died in World War Ш

Completing his advanced training in communications, Roger was assigned to the 369th signal company and was off to a lovely garden spot in a small town /post in Soc-Trang Vietnam. What gorgeous vacation spot to spend the holidays, 51 years past. Roger operated long lines for telephone microwaves communication for 11 months. After returning to the states Roger was honorably discharged from the Army in '71, but his memories are

inescapable and possess a distinct residence in his mind. Roger wasn't the only one in his family to serve in the military, his father served in the U.S. Navy. After military service, Roger began working for American Components and Clifton Precision, both company's produced products that were used by the military in various equipment. After retirement Roger continues to reside in Clay County. He and

the love of his life, Patricia, have two wonderful children and 4 grandchildren and 1 great grandchild. Roger and Patricia, A TREMENDOUS THANK YOU for your faithfully service to our great nation. 

New Screening Procedures Begin Dec. 16

Beginning Dec. 16, 2022, we will no longer have contract screeners stationed at our main entrances.

There will be signage in place to remind all Veterans, visitors, and staff to self-screen. **Surgical masks will still be required** and will be available in the respiratory stations at each main entrance.

To assist with wayfinding, general guidance, and increased customer service, we will be hiring permanent Security Assistants to support both the main campus as well as our CBOCs. We hope to fill these positions within the next few months.

TOXIC EXPOSURE SCREENING

If you are enrolled in VA health care, you can now receive the toxic exposure screening at VA medical centers and clinics across the country. If you are not enrolled but meet eligibility requirements to enroll, you will have an opportunity to receive the screening after you enroll.

During the screening, you will be asked if you believe you experienced toxic exposures during your military service. If you answer yes, you may be connected to support and resources, including a review by your primary care team or provider. As the screening becomes a regular part of your health care, you may have some questions. Here are some quick facts to get to know the process:

- It's quick. The screening is a series of questions that takes around 5-10 minutes and can occur as part of one of your regular health care appointments.
- •It documents a variety of exposures. There are several types of possible exposures or hazards you may have experienced during your military service. This includes open burn pits and airborne hazards, Gulf War-related exposures, Agent Orange, radiation, Camp Lejeune contaminated water exposure and others.
- •It helps support your long-term care plan. The purpose of the toxic exposure screening is to make your VA health care team aware of any potential exposures to toxins during your military service. This allows for ongoing care that ensures early diagnosis and treatment of any health concerns that may arise in the future related to your exposure(s). If you report a



potential toxic exposure, it will be noted in your health record. Your primary care team will be made aware of your concerns and will connect you with resources to address your follow-up questions.

- You will receive additional information. After your screening, you will also receive information about benefits, registry exams, and clinical resources to address any concerns you may have.
- You can ask about the toxic exposure screening at your next VA health care appointment. You will be screened at least once every 5 years.
- You can decline. If you choose not to be screened, you will have the option to decline until the following year.

There are a couple of things to keep in mind:

- •Screenings are not diagnostic. The screenings identifies and documents potential exposures.
- •Screening is not part of the VA Benefits claims process.
- Being screened is separate from joining a VA environmental health registry. VA has six registries: Agent Orange, Airborne Hazards and Open Burn Pits, Depleted Uranium, Gulf War, lonizing Radiation, and Toxic Embedded Fragments. You will receive information about registry participation after your screening.

One of the best ways to manage your health is to proactively develop a long-term care plan with your care team. The new toxic exposure screening can be an important part of that discussion.
