Dear Patients and Colleagues,

I am writing you because I have made the decision to retire from active patient care. This decision is the culmination of a process that has taken a number of years. Prior to the pandemic, I began looking for a well-trained, younger dentist to care for my patients, many of whom I have known for over forty years! This was not an easy task because I set high standards for that person to meet. About a year and a half ago I met Dr. Sam Vijeh. I was particularly impressed with Dr. Vijeh at our first meeting because our discussion centered on tooth conserving techniques and optimal individual patient care.

Dr. Vijeh truly has a passion for helping others and dentistry. He began his career seeing patients in public health settings. He has worked in many high needs areas across the country where he treated patients with complex cases and limited resources. This allowed him to hone in on his skill and passion for conservative dental treatment. After this, Dr. Vijeh spent several years in private practices across the East Bay. He has also been an associate in a prosthodontic office where he designed and created custom restorations himself and saw patients with complicated treatment plans. I believe his



non-aggressive approach and his exposure to advanced dental techniques makes him the perfect fit to take over my duties at the practice.

When Sars-Cov-2 arrived in the early months of 2020 I was still seeing patients. However, in mid-March we cancelled all elective procedures as mandated by the Alameda County Health Department. We had to find a way to treat those patients who were in pain or had serious infections. I realized early on that I was a member of the high-risk group. Dr. Vijeh approached me with the idea of stepping in to treat patients. From that point forward, he has provided comprehensive treatment to my patients.
