DOG BOARDING & DAYCARE AGREEMENT

Thank you for choosing COMPASS K-9 for your pet boarding and daycare needs.

Requirements: All canines must be up to date on all vaccines, including **Bordetella, Rabies, and DHPP**. Official updated vaccination records must be provided prior to entry into daycare or boarding and must be administered at least 3 days prior to either service.

* We reserve the right to refuse to accept a pet at check in for any reason including, without limitation, if it appears to us that the pet is sick, injured, in pain or that its behavior could jeopardize the health or safety of other pets or our staff. If your pet has a medical condition or is on any medication, please see staff so they can evaluate the pet's condition. *

1. **Emergency Contact:** This person should **NOT** be traveling with you if you are leaving town. If we cannot reach you, you authorize us to contact your agent (over the age of 18). You agree that your agent shall have your full and complete authority to make all decisions, including those related to the health of your pet and the expenditure of funds, for or on behalf of you and your pet. This person will also have your authority to pick up your dog in emergencies or if we can no longer board the dog due to unforeseen issues that may arise with your dog.

2. **Emergencies:** If your pet(s) becomes ill or injured in what is deemed by our employees as a nonemergency, and we are unable to reach you, please indicate your wishes below:

___ Please perform whatever services the doctor deems necessary for the best care of my pet until someone can be reached.

In cases we believe to be serious, we will take your pet to the emergency vet first before trying to contact you!

3. **Liability:** You acknowledge and agree that in an unlikely event your pet is injured by another pet you release COMPASS K-9 and its employees from any liability for such injury. If your pet injures another pet, you will be solely responsible for any injury to the other pet (s) as well as your own pet and you release COMPASS K-9 and its employees from any liability for such injury. You understand that it is possible for a pet to become ill even if vaccinated. You assume all the risks and accept the responsibility of all costs for treatments. You further agree to hold the owners and employees of COMPASS K-9 harmless from expenses incurred for such treatment. If your pet destroys any property of COMPASS K-9 during his/her stay with us, you acknowledge and agree that you are responsible for charges incurred to replace such items.

4.) **Payment for Services:** You agree to pay us for the services we provide to your pet during each visit at the rates set forth at the start of such visit. Charges begin on the day you leave your pet. Payments will be required up front. Early pickup is allowed; however, the booked dates will not be refunded. The specific dates have been reserved for your pet and can no longer be filled. If you wish to extend your pets stay, if room exists, these charges can be paid at pick up. At the owner's discretion, allowances can be made for emergency situations.

5. **Dog Daycare:** Please be advised your pet will co-mingle with other dogs (if "dog-friendly"). Infectious diseases, minor injuries, dog bites, etc. may occur even when properly vaccinated dogs interact with each other. Your pet may also be boarded at various times throughout the day for breaks or during

check-in/check-out. Dogs that are not picked up by 5pm will be charged \$5 an hour until 7pm. After 7pm the dog will shift over to boarding. You will be charged the \$25 for daycare and the \$30 for boarding.

6. **Personal Items:** Do not bring items with your pet that are valuable or irreplaceable. COMPASS K-9 is not responsible for loss or damage to personal items or toys left with your pet.

7. **Medications:** All medications must be in a container with a current prescription label from your veterinarian. Supplements not labeled for animals or prescribed by a veterinarian will only be given with your permission and you assume responsibility for their use.

8. **Pick Up:** Pets not picked up on departure date/ Abandoned: If you or your agent does not pick up your pet at the agreed time you hereby authorize us to continue to provide the services as set forth in this Agreement at your expense. If the pet is deemed abandoned under local, state, or federal laws COMPASS K-9 will attempt to contact you by telephone and or in writing advising you that if your pet is not picked up within a reasonable time period your pet will be delivered to a third-party adoption partner, animal control, The Putnam County Humane Society or other similar government agency. You understand that you may lose ownership of your pet under the circumstances. If you fail to pick up your pet for any reason you release COMPASS K-9 from all further liability and responsibility for your pet. You shall remain liable to us for all unpaid charges. Including the court costs and reasonable attorney's fees incurred in the collection of the charges.

**** If you cannot pick up during these times, you can pick up your pet the next day for an additional night's boarding. Unless prior arrangements are made and approved by Compass K-9.**

9. **Miscellaneous Provision:** This written agreement constitutes our entire and only agreement and there are no oral agreements or understandings except as provided for in this agreement. Additional provisions will be added in the space provided and initialed by both Compass K-9 and owner. This Agreement is bound by all State and Local laws of Putnam County and The State of WV. **We reserve the right to use photographs or video footage of your pet taken during their stay. These images may be used for marketing materials, either in print form or on the internet.** This agreement will remain in effect for any current or future pets you may bring to COMPASS K-9 until the time it may be updated.

Please Initial the following:

____ Owner certifies that the dog being boarded is not currently or in the future a source of income or show dog for the owner.

_____ Daycare Dogs that are not picked up by 5pm will be charged \$5 an hour until 7pm. After 7pm the dog will shift over to boarding. You will be charged \$25 for daycare and the \$30 for boarding.

_____ If special services are added the owner agrees to pay for those services. These services are not included in the price of the Boarding. Example: nails, grooming, etc.

_____ Owner understands and agrees that if an unaltered female goes into heat, Compass K-9 will contact you and take all reasonable actions to prevent pregnancy, however owner acknowledges risks and releases Compass K-9 from all liability. Owner can choose to continue boarding with the understanding that the dog will be separated from all other dogs, or owner can elect for emergency contact to pick up the dog. If it becomes a problem due to aggression in other dogs the emergency contact will be required to pick up the dog immediately.
