CEF is implementing a project funded for Lifesaving Protection Services for Returnees from Sudan in Aweil East County and seeks a passionate Child Protection Officer.

Key Responsibilities

- > Oversee and implement child protection activities within the project, ensuring the safety and well-being of children in the target area.
- > Conduct assessments to identify the specific child protection needs of returnee families and vulnerable children, and work to develop targeted interventions.
- Work closely with local authorities, community stakeholders, and other NGOs to create a comprehensive child protection network in Aweil East County.
- > Train and support community members, volunteers, and staff in child protection principles and practices, ensuring they understand their roles in safeguarding children.
- > Establish monitoring and evaluation frameworks to assess project impact, collect data, and submit timely reports on child protection activities and challenges.
