This Release specifically covers claims caused in whole or in part by any U.S. national health crisis, epidemic, pandemic, or similar widespread outbreak of disease whether or not such is formally declared by the U.S. government, the Center for Disease Control or the World Health Organization. Mission: To provide Liberty Middle School Students an opportunity to engage and learn with community leaders and peers in an enriching and safe environment.

LASSO is committed to providing a safe, positive, and structured environment. The program is run by volunteers within the community and hosted by Lemoore Presbyterian Church. All volunteers have completed LiveScan fingerprinting and background checks as well as online training* as required by the State of California. To make the most of the program, we need all students to follow appropriate behavior from the first day. This allows us to maintain the quality and safety of every activity for all of our participating students.

Please review the following general rules and guidelines and disciplinary consequences that will guide the program. It is essential that both students and parents understand the expectations of the program as well as the potential consequences. We ask that you discuss the information below with your child. We appreciate your support in making appropriate behavior a priority for all students.
