Base fees are charged to all services monthly regardless of whether the service has usage or not.

**SECOND:** The Subscriber agrees to pay promptly on a monthly basis: (1) a minimum monthly water/sewer bill as assessed by the water supplier; (2) any water registered by the meter serving the property that is in excess of the minimum monthly bill as the rate or rates set by the water supplier. **The bill is due on or before the 10<sup>th</sup>. A \$5.00 penalty will be added on the 11<sup>th</sup>. A \$20.00 penalty will be added on the 21<sup>st</sup>. IF NOT PAID BY THE 21<sup>ST</sup> A \$30.00 SERVICE FEE SHALL BE CHARGED AND THE METER WILL BE LOCKED. Bill must be paid by 3:00 p.m. for same day reconnection. A \$40.00 fee will be charged for all returned checks. After three returned checks, a customer will be placed on a cash only basis permanently.**

**THIRD: EXTENSION POLICY, Customer's are eligible for Five (5) payment Extensions per year. Extensions prevent customers from being shut-off for non pay and will prevent the \$30.00 service fee from being added to the past due bill. However, Extensions do not EXCLUDE the \$5.00 penalty and \$20.00 interest which will be included in the total due.**

**FOURTH:** The subscriber agrees to install and maintain at his own expense a service line, cut-off valve, and on commercial and industrial accounts an approved backflow prevention device on the Subscriber's side of the meter. The cut-off valve must be in outside the meter box.

**FIFTH:** The Subscriber grants the District, its agents, and employees, the right of ingress and egress, over, across, under and through said property for any reason related to the use, maintenance, repair or otherwise of the District's water and/or sewer facilities.

**SIXTH:** The Subscriber agrees that no other present or future source of water will be connected to any water lines being served by the District's water lines and will be disconnected from any present water supply system prior to connecting to the District system. The Subscriber will be required to maintain any air gap between holding water from any other source other than water supplied by the District's agent.

**SEVENTH:** The Subscriber understands that this water tap is for the use of consumer, members of the household, employees and/or visitors only. The consumer shall not allow anyone else to connect onto the water and or sewer system serving the consumer. This service is for one dwelling or business only. Any subscriber with an unauthorized connection will be fined \$500.00 and the service will be disconnected immediately. Service will not be reinstated until all fines and penalties are paid in advance and any illegal connections permanently removed.
