Children’s Information

Mavericks Wrestling serves youth athletes. We collect information about minors **only from parents or legal guardians** in connection with program participation.

We do not knowingly collect personal information directly from children under 13 without parental consent.

3. Weather and Schedule Changes

No refunds will be issued for:
