 - **-2.09 Proxies -** Can we get further explanation on what we need to do for meetings to have proxies be most effective/lagal for meetings?

- Financials Does the ditch need to do a financial audit Should we hire an outside bookkeeper? Many requests have been made to the Treasurer to provide financials and shareholders that have not kept current on their dues and those requests have gone unanswered. It was suggested at the 2022 meeting by former attorney Rich Livingston that we possibly form a financial committee to go over financials and determine how our financial needs and security are being met/addressed finances should be audited annually. (Also the considerations of setting annual budgets that are approved by Board members hard to do with unknown repair factors along the ditch). Future motion to form a financial committee to be responsible for annual audits.
- Setting guidelines/written policies for low water years (rotating days, times of day for usage, etc).
- Creating a Mission Statement.
- Create/Draft a document with both short and long term goals and objectives.
- Create a job description for the Ditch Rider.
